## "Undergraduate Research: The Future at Eastern Illinois University"

A group from EIU recently attended a conference on undergraduate research. In this interview, Godson Obia, Associate Dean of the College of Sciences, describes the conference and its significance. Implementation of the group's recommendations would result in some major changes at Eastern.

# 1. You recently attended a conference on undergraduate research. What was the focus of the conference?

We attended a workshop on "Institutionalizing Undergraduate Research, Scholarly, and Creative Work," at Murray State University, from March 4-5, 2005.

The focus of the workshop was to "help campuses initiate and expand campus-wide programs to engage undergraduates in research, scholarly, and creative work."

#### 2. Who attended from EIU?

Dr. Andrew Methven, Chair of Biological Sciences; Dr. Vince Gutowski, Geology-Geography Department; and Dr. Godson Obia, Associate Dean of the College of Sciences represented Eastern.

# 3. Who sponsored the conference, and what is this organization's expertise in promoting undergraduate research?

The workshop was organized by Murray State University, with collaboration from the Council on Undergraduate Research (CUR), and sponsored by the Howard Hughes Medical Institute Program at Murray State University. Murray State has a Center for Undergraduate Research, funded by the Howard Hughes Medical Institute, which collaborates with CUR to organize national workshops.

#### 4. What were the major points covered during the conference?

The conference provided an opportunity for each team of participants to: 1) identify the strengths, weaknesses, impediments, and opportunities for undergraduate research on their campuses; and, 2) generate short-term, mid-term, and long-term goals for enhancing undergraduate research, scholarly activity, and creative work on their campuses.

#### 5. Did anything unexpected emerge during the conference?

The outcome of the conference was expected. The team from Eastern Illinois University developed the following short-term (3-6 months), medium-term (2-3 years), and long-term goals (5 years):

#### Short-Term Goals (3-6 months):

- Prepare a report on the workshop that will be shared with the COS Chairs, the Council of Deans, and the Provost and Vice President for Academic Affairs
- Encourage the Deans of the College of Sciences and the College of Arts and Humanities to select and fund a team of representatives to attend a Council on Undergraduate Research (CUR) Institute July 22-24, 2005 at Bridgewater State College, Bridgewater, MA titled Mentorship, Collaboration, and Undergraduate Research in Social Sciences and Humanities

#### **Short-Term Goals Continued:**

• Identify a small group of faculty and campus leaders of undergraduate research, scholarly activity, and creative work on Eastern's campus to serve as a organizing committee

- Obtain buy-in from key campus constituencies
- Enable the organizing committee to prepare an inventory of the kinds of research, scholarly activities, and creative work that are currently in progress on campus and to gauge interest in colleges and departments in pursuing a university-wide initiative to encourage undergraduate research, scholarly activity, and creative work on campus

#### Mid-Term Goals (2-3 years):

- Enable the organizing steering committee to work toward accomplishing the mid-term and longterm goals outlined in this summary
- Enable the organizing committee to establish assessment tools for evaluating undergraduate research, scholarly activity, and creative work on campus
- Organize a campus-wide exposition on undergraduate student research, scholarly activity, and creative work in Spring 2007

#### Long-Term Goals (5 years):

- Establish an undergraduate advisory board that includes faculty, students, campus leaders, and representatives from the Honors College, Grants and Research, and the Library
- Integrate undergraduate research, scholarly activity, and creative work across campus
- Enhance undergraduate research grants for the academic year and the summer session
- Enhance student travel to meetings and expositions
- Establish an Office for Undergraduate Research, Scholarly Activity, and Creative Work with a half-time Director

# 6. How does EIU's engagement in undergraduate research compare with that of other comparable institutions?

EIU seems to be ahead of many other comparable schools in undergraduate research, in the sense that we generally engage our students in undergraduate research as a part of their degree programs, especially in the College of Sciences. What we lack is a coordinated effort to bring all undergraduate research under one institutional framework. Schools like Murray State are ahead of Eastern, because they have established a center for undergraduate research responsible for coordinating all undergraduate research on their campuses.

#### 7. Will EIU do anything different as a result of the conference?

Plans are afoot to send a team of faculty, if possible drawn from all the colleges, to attend a CUR workshop. We plan to work with the Provost, Deans, Director of Grants and Research, and other relevant leaders on campus to inventory existing undergraduate research engagement, and develop a university-wide plan to coordinate and celebrate undergraduate research efforts, perhaps similar to the College of Sciences' ScienceFest.

#### FY2006 COUNCIL ON FACULTY RESEARCH GRANT COMPETITION

The Council on Faculty Research Fall Competition funds projects for research and creative activity. Funds are available for commodities, contractual services, equipment, travel, and student help related to the project. No personal services dollars are available. All tenured/tenure track faculty in Bargaining Unit A and department chairs and associate chairs are eligible to submit in the Fall, 2005 competition. Beginning with awards made during the Fall, 2005 competition, any individual may receive only two consecutive Fall awards, after which the individual will be ineligible for a Fall award in the third year. Specifically, receipt of an award for the Fall 2005 and Fall 2006 competition will make an individual ineligible for an award in the Fall 2007 competition; eligibility will resume in the Fall of 2008. # **Campus Spotlight**



Selected Accomplishments at EIU

- Dr. Scott AGM Crawford has been on the faculty at EIU since 1989. In 1994 he received a NEH Summer Fellowship in Visual Anthropology at the University of California, Berkeley and in 1996 a NEH Summer Fellowship in Maritime Affairs at Mystic Seaport Museum, Connecticut. He has published extensively in the area of sports studies since 1975 and from 1990-2005 he was the book reviews editor of the International Journal of Sports History. His work has appeared in the Canadian Journal of Applied Sport Sciences, South African Journal for Research in Sport, Research Papers in Physical Education, International Review of Sport Sociology, Journal of Sport Literature, International Journal of Sport Psychology, Victorian Periodicals Review, Journal of Sport and Social Issues, Journal of Sport History and the International Journal of the Society for Nautical Research. His biographical profiles have appeared in numerous publications including the New Oxford Dictionary of National Biography. In 2003 he edited a Frank Cass volume entitled Serious Sport. He is a Fellow of the Royal Society of Arts and in 2005 is the Presidential Scholar of the Illinois Association for Health, Physical Education and Recreation.
- Richard Palmer is the Lumpkin Distinguished Professor of Business at Eastern Illinois University. Prior to academic work, he held management positions in both public accounting and the banking industry. Dr. Palmer currently studies issues in accounting systems, strategic cost management, and process performance measurement. His specific interests include e-procurement and commercial card technology applications to business. His writings have appeared in a variety of journals, including the Journal of Accountancy, Journal of Cost Management, Government Finance Review, Management Accounting, European Management Journal, Behavioral Research in Accounting, Issues in Accounting Education, Journal of Systems Management, and the Stanford University Working Paper series. He has received research grants from organizations such as KPMG LLP, the American Institute of Certified Public Accountants, and the Boeing Center on Technology, Information, and Manufacturing at Washington University in St. Louis. Richard's e-commerce and purchasing card research have been quoted in outlets including CBS News MarketWatch, American Banker, Business Finance, Purchasing, CFO, Treasury and Risk Management, Financial Executive, Credit Card News, Cards International, Credit Card Management, Federal Times, Government Procurement, and Business Integration.
- Professor Nancy Van Cleave's research in theoretical Computer Science has resulted in several conference papers and an article in Springer-Verlag Lecture Notes. Dr. Van Cleave has also been very active in advancing computer science education. She was the Principal Investigator on an NSF-funded project that developed a culturally-sensitive computer science transfer degree for American Indians at a community college. Her work with mathematics education for minorities has resulted in several conference papers, one of which was selected for best conference paper at a large conference. Prof. Van Cleave's interest in new learning activities for students has led to numerous presentations at meetings of mathematics educators and computer science educators. Her current research centers on the creation of learning objects and their electronic delivery to students. Dr. Van Cleave's collaborators include Terence Ahern, as well as EIU computer scientists Peter Andrews, Andrew Mertz, and Bill Slough..
- Dr. Jean Wolski has written several plays for children and has toured shows throughout the Midwest.
  She has served on the editorial boards for YOUTH THEATRE JOURNAL and STAGE OF THE ART and
  is collaborating on a text in the area of Youth Theatre. Her specialization in. the field of acting is in voice
  and movement, incorporating her degree in music with training in dance. Prof. Wolski is currently
  serving as editor for ATME NEWS, a publication of the Association of Theatre Movement Educators. In
  addition to teaching, Dr. Wolski has directed and/or choreographed several productions, including
  BRIGADOON and TWELFTH NIGHT.
