NSF Data Management Plan Requirements

Proposals submitted or due on or after January 18, 2011, must include a supplementary document of no more than two pages labeled "Data Management Plan". This supplementary document should describe how the proposal will conform to NSF policy on the dissemination and sharing of research results. See Grant Proposal Guide (GPG) Chapter II.C.2.j for full policy implementation.

President's Research Fund

Grants from the President's Research Fund will be available starting July 1, 2012. Applications are due at noon on October 3, 2011. See the program description on page 5.

Council on Faculty Research Grant Competition

Grants from the Council on Faculty Research will be available this fall. Applications are due at noon on September 7, 2011. See the program description on page 6.

Proposal Initiative Fund Grant Competition

Grants from the Proposal Initiative Fund will be available this fall. Applications are due at noon on October 26, 2011. See the program description on page 5.

Electronic Searches for Grant Opportunities

Several search engines on the Research and Sponsored Programs website are useful for seeking grant opportunities. Participants will learn important search techniques and methods of conducting regular, automated searches for external funding.

Introduction to Proposals for External Funding

Anyone who is relatively new to submitting proposals to external agencies will benefit from this seminar. The presentation will include: (1) a description of major sections of typical proposal; (2) a brief description of how to construct a budget; (3) Eastern's internal requirements for approval of proposals before they are submitted; (4) Eastern's internal procedures for handling money after a grant has been approved, and (5) regulatory issues such as protection of animals and human subjects.

How to Write a Proposal to the Council on Faculty Research

Dec. 6, 2011 3:00 – 4:00 P.M. Greenup Room

Eastern's internal funding for research and creative activity is awarded on a competitive basis by the Council on Faculty Research. There are two rounds of funding, one in the fall and one in the spring. This presentation will include suggestions for making a proposal competitive, as well as examples of recent funded proposals.

FY2013 PRESIDENT'S RESEARCH FUND

The purpose of the President's Research Fund (PRF) is to support projects with potential to lead to significant external funding of research and/or scholarship. Faculty members from both Unit A and Unit B are eligible to apply.

Applicants agree to submit at least one proposal for external funding within 12 months of the end of the PRF grant. The total amount of external funding requested must be at least four times the amount of PRF funding awarded. PRF proposals are evaluated by external reviewers and by an internal advisory board appointed by the President of Eastern Illinois University. The President makes all final funding decisions.

Proposals for up to \$20,000 will be accepted. Total funding of \$100,000 is anticipated for FY2013. Successful applicants can expect to begin expending PRF funds in July, 2012.

FY2012 PROPOSAL INITIATIVE FUND ROUND 2

The purpose of the Proposal Initiative Fund (PIF) is to support projects with potential to lead to significant external funding. Normally, anyone who accepts a PIF grant will agree in writing to submit a proposal for external funding within 12 months of the end of the PIF grant. There are two types of PIF grants: Type A (maximum of \$1,500) and Type B (maximum of \$7,500). Applicants for Type A grants must demonstrate plans to apply for an external grant worth a total of at least \$20,000 within one year of the end of the Type A grant. Applicants for Type B grants must demonstrate plans to apply for an external grant worth at least \$50,000 per year within one year of the end of the Type B grant.

FY2012 COUNCIL ON FACUTLY RESEARCH (CFR) GRANT COMPETITION

The Council on Faculty Research (CFR) grant competition will be held in early September. The Council supports research and creative activity. Proposed projects must address a significant scholarly issue. All tenured/tenure track faculty in Bargaining Unit A, department chairs, and associate chairs are eligible to submit in the Fall 2011 (FY12) competition. Beginning with awards made during the Fall 2005 competition, any individual may receive only two consecutive Fall awards, after which the individual will be ineligible for a Fall award in the third year. Specifically, receipt of an award for the FY2010 and FY2011 competition will make an individual ineligible for an award in the FY2012 competition; eligibility will resume in the FY2013 competition. Eligible persons who wish to apply for funding from the CFR should hand-deliver one copy of their proposal to the Office of Research and Sponsored Programs, 1102 Blair Hall, no later than 12:00 noon, Wednesday, September 7, 2011. Researchers who have previously received a CFR grant and/or Summer Research Award should make sure a progress/final report is on file for each award in the Office of Research and Sponsored Programs.
