### **New Requirement for NSF Projects**

The National Science Foundation has announced a new requirement that will apply beginning with proposals submitted on January 4, 2009 and afterward. All students (graduate and undergraduate) and all postdocs who are supported by NSF grants must receive training in the Responsible Conduct of Research (RCR).
