



Mortality of College Students Varies From What Was Predicted, *By Lacey Johnson*

A researcher at the University of Virginia has found that mortality rates among college students are lower, and leading causes of death are different, from what was previously estimated, according to data posted by the American Public Health Association.

Causes of student mortality are often predicted based on numbers for the general population of 18- to 24-year-olds. But after the American College Health Association surveyed officials at four-year colleges enrolling more than 1.3 million students in 2009-10, the data showed a significant gap, with college students having a lower mortality rate than do their peers not in college. The survey also found that students died more from suicide and less from automobile accidents and alcohol-related injuries than was previously thought.

Vehicular injuries and suicide were almost equal as causes of death, contributing to between 6 and 7 deaths for every 100,000 students. Previous estimates had ranked vehicular accidents as more than twice as likely as suicide to be responsible for student deaths. Alcohol-related mortality was also substantially lower than predicted, according to the Virginia researcher, James C. Turner, who is the university's director of student health.

Ralph W. Hingson, of the National Institutes of Health's Institute on Alcohol Abuse and Alcoholism, has closely studied trends in alcohol-related deaths on college campuses. In an interview with *The Washington Post*, he said that mortality statistics provided by colleges were likely to be underestimated because administrators are not required to track or report student deaths.

Prescription Drug Overdoses are a Public Epidemic

“In a period of nine months, a tiny Kentucky county of fewer than 12,000 people sees at 53-year old, her 35-year old son, and seven others die from by overdosing on pain medications.”

According to the Center for Disease Control and Prevention (CDC), prescription drug overdoses has increased drastically in the last decade. In fact, the number of overdoses from prescription drugs has more than tripled since 1990. More than 36,000 individuals died from overdoses (mostly prescription drugs) in 2008. Nearly three out of four drug overdoses are from prescription painkillers.

With the high number of deaths the prescription drug misuse has become an epidemic in the United States. In 2010, enough prescription painkillers were prescribed to medicate an adult around the clock for one month.

There are groups more likely to overdose or misuse prescription drugs. The following groups were given by the CDC:

- More men die from prescription painkiller
- Middle-aged adults have a higher overdose rates
- Individuals in rural counties are twice as likely than those in big cities
- Whites and American Indian or Alaska Natives have higher rates of overdosing
- Approximately 1 in 10 American Indian or Alaska Natives aged 12 or older used prescription painkillers for nonmedical reasons in the past year, compared to 1 in 20 whites and 1 in 30 blacks – CDC, 2011

The most commonly misused prescription drugs include:

- Opioids: Used for pain relief. Found in hydrocodone (Vicodin), oxycodone (OxyContin), fentanyl (Duragesic), methadone, and codeine.
- Benzodiazepines: Used as sedative, induce sleep, prevent seizures, and relieve anxiety. Found in alprazolam (Xanax), diazepam (Valium), and lorazepam (Ativan).
- Amphetamine-like drugs: Used to treat attention deficit hyperactivity disorder (ADHD). Found in dextroamphetamine (Adderall) and methylphenidate (Ritalin). –CDC, 2011
