Midwest Social Norms Institute 2011

The Midwest Social Norms Institute is two days of intensive training to enhance and expand professional skills in using the social norms approach to prevention. This workshop will provide opportunities for experienced prevention workers to move to the next level and strengthen their social norms programs, while providing those new to the field with background and skills to begin using this innovative and positive approach.

The Social Norms Approach is an evidence-based method used across the United States and in the U.K. to successfully address a variety of health and safety issues such as bullying, teen alcohol and drug use, and obesity. Organizations using the social norms approach have consistently been awarded grants from SAMHSA and the U.S. Department of Education. This two-day training will be conducted by the founders of the social norms approach, H. Wesley Perkins, Ph.D. and Michael Haines, M.S. Together, they will provide instruction and insight gained from more than twenty years of work with high schools, colleges, states and community agencies.

Is your school's underage drinking policy effective?

The Underage Drinking Enforcement Training Center (UDETC) is offering a **free** webinar on June 23, 2011 at 2:00p.m. CST.

College's can play a significant role in preventing underage alcohol use and should be included in all comprehensive efforts to reduce underage drinking. Reducing underage drinking on college campuses is an important goal of school administrators because of the many negative consequences resulting from alcohol misuse. With most school years winding down in May and June it's now an opportune time to consider the effectiveness of your school's policy on underage youth access/consumption of alcohol. Many policies are dated or not as effective as they should be. Also worth reviewing is the enforcement of school policies. Evidence indicates that policies can only work if they are enforced-so effective policies will include partnerships with law enforcement. This audio call will discuss why is it important to have an alcohol policy, share sample policies, identify key components and outline the responsibilities and roles of both enforcement and communities. The presenters will discuss successful school polices that can be modeled to address the goal of healthier and safer campuses.

Listserv for College Student Suicide Prevention Programming

Many universities all over the country have recognized the need for comprehensive suicide preventative services. While there are various listservs that can be used to network and discuss college student mental health, there is no tool that facilitates a way for all campus personnel working on suicide prevention to communicate in an open forum that is used explicitly for the discussion of suicide prevention programming.

It is this vacancy that led me to create the College Student Suicide (CSSP) Listserv. This national listserv serves as a tool for university personnel (be they staff or faculty members) who are working to prevent college student suicide on their campus. The purpose of this forum is to exchange ideas, promote discussion and generally improve the quality of suicide prevention programming on college campuses.

Examples of how this listsery can be utilized include:

- Sharing ideas for outreach programming for campus events centered around suicide prevention
- Sharing campus resources or materials created explicitly for suicide prevention
- Promoting/publicizing events conferences, trainings, etc. that have a focus on suicide prevention
- Soliciting feedback from your colleagues on potential guest speakers to bring to campus
- Problem solving issues that may arise on your campus when talking about suicide prevention
- Ways to support and work with students who want to help raise awareness about this issue on your campus
- · Forum to share news articles, opinion pieces, videos etc. that center upon college student mental health and/or suicide prevention.
