VERY IMPORTANT: The following materials MUST be submitted for your application to be considered complete:

- The application form
- Complete and official transcripts from all higher education course work (must be sent directly to the EIU at the address indicated at the bottom of this page; transcripts of course work completed at EIU are not required)
- 300-word essay expressing your interest in the program and career in education
- Documentation from employer(s) verifying five years of employment (see form in this packet; photocopy as needed; provide information about yourself; then mail or fax to employers and ask them to return the forms to you)
- Your current résumé
- Official letter providing evidence of commitment from a school district to hire you for a full-time teaching internship for the 2012-2013 school year
- Report indicating passing score on Illinois Basic Skills and appropriate Subject-Matter Knowledge tests
- A \$30.00 nonrefundable application fee as a check or money order made payable to Eastern Illinois University.

Note: A criminal background check must be performed as a part of the admissions process. More information about the requirements and procedures is available online. Find FBI Fingerprint information at the www.eiu.edu/~clinical web site.

When to submit your application packet:

- **The application deadline for 2012 is April 30, 2012.**
- Late applications will be processed for the next year's cohort.

How the candidate selection process works:

Written Application:

- Application packet materials will be evaluated on an ongoing basis.
- Candidates will be successful in this step if their credentials meet the following requirements:
 - Complete set of higher education transcripts, verifying a major or its equivalent in the intended area of certification and a GPA of 2.65 on a 4.0 scale
 - 300-word typed essay expressing interest in the program and a career in education
 - Form(s) verifying five years experience applying knowledge in intended certification area
 - Your current résumé
 - Official letter providing evidence of commitment from a school district to hire you for a full-time teaching internship for the 2012-2013 school year
 - Evidence of passing Illinois Certification Testing System Basic Skills and appropriate Subject-Matter Knowledge Tests (when registering, be sure to indicate that scores should be sent to EIU)

Interview:

- Applicants who meet written application requirements will be invited to demonstrate through a standardized interview with teacher educators and school personnel the dispositions necessary to succeed as teachers in a typical school setting. These interviews will be scheduled as needed.

Criminal Background Check:

- State law requires any candidate for teacher certification to undergo a Criminal Background Check. This check is required even for those who may have completed one elsewhere. Find FBI Fingerprint information at the www.eiu.edu/~clinical web site.
