Visionary Society

The Visionary Society recognizes those individuals and organizations who, during the previous calendar year, established endowments in support of the educational mission of the University. These visionaries are investing in the future of Eastern Illinois University by providing long-term support with funds for scholarships, faculty research grants and/or University educational and cultural enrichment programs.

*Judy Ethell Faculty Excellence Fund

Judy Ethell has established this endowment to provide awards for EIU School of Business faculty development and research activities as determined by the chair of the EIU School of Business. First preference should be given to accounting faculty. The endowment will be funded by a bequest from her estate.

William Gene and Brigitte Johanna Brown Scholarship

William Gene and Brigitte Johanna Brown established this endowment for full-time students majoring in pre-engineering in even-numbered fiscal years and to students majoring in foreign languages in odd-numbered fiscal years. Among other specific requirements related to each discipline, students must have at least a 3.0 GPA. Preference will be given to students participating in Eastern's study abroad programs.

*Michael Chron Women's Basketball Athlete Scholarship

Established by Michael Chron, this award will be for entering freshmen who are academically and athletically eligible, participating in women's basketball, and who do not receive any other athletic scholarship. The scholarship is given to a student who demonstrates the greatest potential for success in basketball. This endowment will be funded by a bequest in his estate plan.

Mary Jane Coartney Memorial Creative Writing Scholarship

Established by family and friends of Mary Jane Coartney, this scholarship is for a full-time student who is a junior at the time of the award, and who is majoring in English, history, journalism or theater arts, and demonstrates the greatest ability in creative writing.

David Coon Memorial Scholarship

Established by the family of David Coon, this scholarship is for full-time students majoring in special education. The recipient must submit an essay that illustrates how working with students with special needs has impacted the recipient, and how he/she hopes to impact students with special needs through education.

The recipient must have a GPA of at least 3.0. Financial need is a consideration.

*Drake-Regan First Generation Scholarship

Established by Dorothy Drake in memory of her husband, Donald Erik Drake, this award is for full-time first generation college students in good academic standing. Financial need is a consideration. This endowment will be funded by a bequest in her estate plan.

Kenneth E. Hadwiger Ph.D. Graduate Scholarship

This fund was established by Kenneth E. Hadwiger to help recruit and retain faculty in the Department of Communication Studies. The award is for a full-time graduate student whose parent is a faculty member with a Ph.D. and who has taught at Eastern for at least two years.

Ebrahim and Donna Karbassioon Graduate Economics Scholarship

Established by Ebrahim and Donna Karbassioon, this fund will provide a scholarship for a full-time graduate student majoring in economics. The recipient must have a GPA of at least 3.0, display academic integrity, and demonstrate promise of a successful career in economics.

June Krutza Art Scholarship

Established by June Krutza, this scholarship is for a full-time junior or senior majoring in art studio 3-D, ceramics, jewelry/metalsmithing or sculpture. Preference will be given to a recipient specializing in ceramics. The recipient must submit a portfolio of representative of 3D studio artwork, and must have a minimum GPA of 3.0.

Daniel E. Marvin Jr. WEIU Scholarship

Established by Maxine Marvin and friends and family of Daniel E. Marvin Jr., this fund is for full-time students majoring in journalism or communication studies and having a concentration in broadcast news or media production. The recipient must have completed a minimum of 30 semester hours, must have worked a minimum of two semesters in the television or radio station, and have a minimum GPA of 3.0 at the time of the award.

Visionary Society (continued)

Dolly J. and H. Gene McFarland Kinesiology and Sports Studies Scholarship

Dolly J. and H. Gene McFarland established this fund for full-time students majoring in kinesiology and sports studies and who are working toward a teaching degree. The recipient must have a GPA of at least 2.5 and be a resident of Illinois.

Rodney Ranes Graduate Faculty Mentor Award

Established by friends of Rodney S. Ranes, this award is for current and continuing tenured/tenure track full-time faculty of EIU's graduate programs. The recipient must be nominated for the award by a degree-seeking graduate student, must demonstrate the highest standards of discipline knowledge and achievement, and demonstrate unique characteristics that contributed to the graduate student's success. The award will be used to support the recipient's pursuit of scholarship appropriate to the teaching/research/service requirements of graduate faculty at Eastern.

Alumni and Friends of Soccer Scholarship

Represented by Jim Harkness, alumni and friends of soccer have established a four-year scholarship for a full-time undergraduate student eligible to participate in intercollegiate athletics. The recipient must maintain at least a 2.5 GPA, must make the men's soccer team roster, remain in good standing on the team, and be in compliance with NCAA and University regulations.

*C. Roger Sorensen Supplemental Instruction Program Endowment

This endowment will be used to fund a 10-month, monthly stipend for one graduate assistant who has been accepted into the Graduate Business Studies Program in the School of Business as a degree-seeking candidate pursuing a master's degree in business administration. Preference will be given to students who have completed their undergraduate business core courses at EIU. Funds in excess of the assistantship stipend may be used for special achievement awards, faculty development, special conferences, guest speakers, consultants, technology renewal and capital projects. This endowment will be funded through an estate gift.

*C. Roger Sorensen "Completion of Degree" Scholarship

This endowment is for a senior athlete in any sport who has exhausted their eligibility. The athlete must have been eligible for competition the last semester before this scholarship is awarded and be within one semester of graduation. This endowment will be funded through an estate gift.

*Cal and Judy Stockman Music Education Scholarship

Cal and Judy Stockman have established this scholarship for a sophomore, junior or senior full-time student enrolled in the teacher certification option and who demonstrates a potential in the field of music education and who has a minimum GPA of 3.0. This endowment will be funded by a gift from their estate.

David Frank Tanner/Ronald Eugene Gholson Endowed Fund Celebrating the "Goodness" of Music

Established by Ronald E. Gholson, this fund will be used for students participating in the jazz studies program, for such expenses as the purchase of music, instruments, equipment and performance clothing; for travel for faculty or students to competitions; and for recording of music performances and student recitals. Scholarships may also be awarded to students subject to criteria determined by the director of the jazz studies program in consultation with the chair of the Department of Music, and the dean of the College of Arts and Humanities.

Edward and Connie Taylor have established this fund for a sophomore whose family is engaged in farming and the majority of the family's annual gross income is from a farm-related activity. Preference is given to a student exhibiting the greatest financial need and who has a GPA of at least 2.5. This endowment will be funded by a bequest from their estate.

Established by Joan Stough, this scholarship will be for a full-time student majoring in foreign languages. 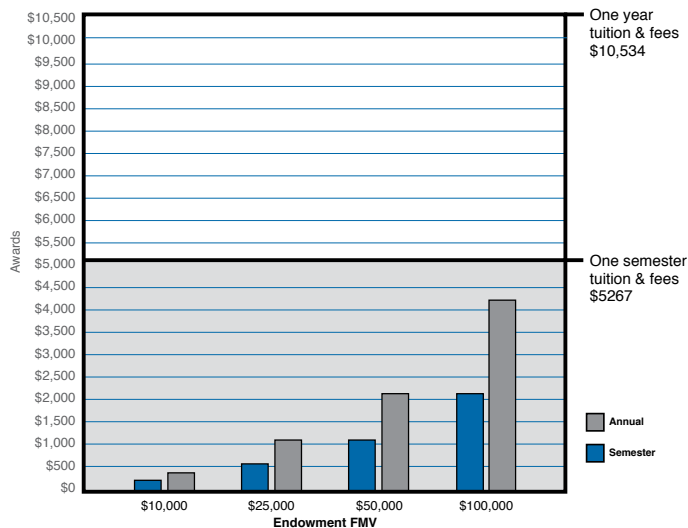
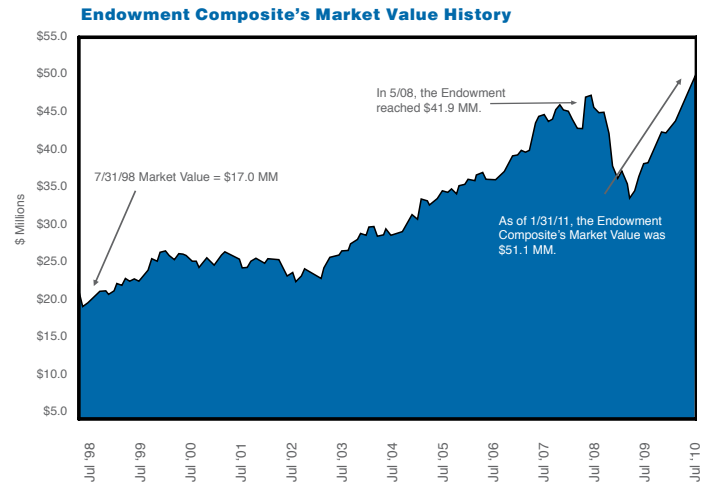

What the Data Means

The Foundation Board fulfills their fiduciary responsibility to manage the Endowment portfolio by exercising careful due diligence based on our risk tolerance, goals and investment horizon. Risk and reward are inextricably intertwined—there is no asset that is without risk—so while no one can control outcomes, one can control risk to a certain degree. Consequently, the portfolio is constructed by investing in a range of assets that allows adjustment of risk and reward depending on the relative attractiveness of the underlying assets.

The 2008-2009 Financial Crisis was one of the worst periods for assets in U.S. history, which significantly impacted portfolios throughout the country. Through asset allocation, the Foundation proactively balanced the Endowment's risk and reward structure based on the volatility of the financial markets to take advantage of the financial dislocations. Consequently, the Endowment portfolio's 2010 calendar year return of 12.8%, the second consecutive year of strong gains. As the chart below depicts, the year-end Endowment portfolio market value reached a record high level of \$50.6 million. Since the 1998 inception of the Mercer (formerly called Hammond Associates) relationship, the Endowment portfolio net of fees has an annualized 5.8% return through year-end 2010, which is above our 5% annual target.



The graph to the left illustrates the reach of the Endowment dollars by a comparison of tuition and fees to scholarships and awards that are generated from a sample of Endowment values. The combination of ever increasing costs and lower State education funding means your gifts are more important than ever to the University and students.
