State Requirements for Illinois Driver Education Endorsement

The state of Illinois, through the Illinois Office of Education, requires 16 semester hours for endorsement on the secondary education certificate as a driver education teacher. However, students must submit transcripts for evaluation and must take course work in simulation and range to be qualified in schools that use these methods as follows:

- a. 5 semester hours in driver education - HST 3310, HST 3320
- b. 3 semester hours in general safety - HST 3300, HST 3330 or 3340
- c. 8 semester hours in subjects chosen from two or more of the following related areas:
 1. Additional safety courses
 2. Advanced psychology and sociology
 3. Health Studies
 4. Instructional materials in safety
- d. **Teachers assigned to either simulation or multiple-car (range) programs MUST have preparation in the use of these methods, which shall consist of one (1) semester hour in each area. HST 4900 satisfies this requirement.**

Course Descriptions Summer, 2002:

HST 3300 - Principles of Accident Prevention. (2-0-2) Safety problems of modern life in the home, school, during recreation, on the highway, and at work. The student will develop risk assessment strategies on a personal and societal level.

HST 3310 - Introduction to Driver Education. (3-2-4) Preparation for high school driver education teachers. Includes work with beginning drivers. Prerequisite: Driver's license and safe driving record.

HST 3320 - Advanced Driver Education. (3-0-3) Administration, organization, finance, special programs, evaluation of school driver education programs.

HST 3330 - Advanced Driving Maneuvers. (1-2-2) Designed to teach emergency procedures and evasive actions and to help students better understand their capabilities and limitations as drivers, and the capabilities and limitations of the vehicles they drive. Prerequisite: Health Studies 3310 or permission of the instructor.

HST 4900 - Multi-Phase Driver Education. (2-2-3) The first-phase driver education curriculum. Actual practice with multi-media equipment-simulators, student response systems and the multi-car range. Prerequisite: Health Studies 3310 or concurrent enrollment or permission of the instructor.
