- Implementation of effective prevention strategies



Alcohol Enforcement Officer Course

If underage drinking is a problem in your community, be sure to register for the Alcohol Enforcement Officer course! The course is sponsored by Enforcing Underage Drinking Laws (EUDL) and the Illinois Higher Education Center for alcohol, other drug, and violence prevention. Registration is available for one, two, or three days of training at Eastern Illinois University.

The course will be held in the University-MLK Union on April 12-14, 2011.

Certified by the Illinois Law Enforcement Training and Standards Board, this course is for officers, university personnel and prevention professionals who will become spokespersons for their community to address issues related to alcohol enforcement. Participants will receive a 1, 2 or 3 day certificate based upon the number of days attended.



Free On-line Violence Prevention Course

The Center for Disease Control and Prevention (CDC) is helping the nation prevent violence by providing a free on-line course that's available 24 hours a day, seven days a week. It's called Principles of Prevention. The course—which offers continuing education credits—teaches key concepts of primary prevention, the public health approach, and the social-ecological model. Participants complete interactive exercises to learn to help prevent five types of violence:

- Child abuse and neglect
- Intimate partner violence
- Sexual violence
- Suicide
- Youth violence

The course is designed for those working to stop violence from ever happening. It helps professionals move from the problem to the solution. This course teaches the fundamentals of effective violence prevention methods and incorporates the growing body of research on what works.

The Principles of Prevention course includes:

- Interviews with leading experts in the field
- Dynamic graphics
- Interactive exercises
- Compelling storytelling that makes the case for violence prevention

Supporting Students in Recovery on College Campuses

A recent article entitled "Supporting Students in Recovery on College Campuses: Opportunities for Student Affairs Professionals" has recently been published in the *Journal of Student Affairs Research and Practice*.

Despite the significant attention that drugs and alcohol receive on college campuses, few resources and supports are available to students who are recovering from an addiction. Student affairs professionals are uniquely positioned to support these students with a variety of strategies. This article summarizes what is currently known about college students in recovery and ways that student affairs professionals can help build an infrastructure of formal and informal supports for this underserved and at-risk student population.
