





G. University Highlights

AROUND CAMPUS

EIU allowed to increase tuition waivers. The Illinois Legislature has granted EIU the ability to help low- to middle-income students by offering more tuition waivers. Under the previous law, all state universities were allowed to provide waivers totaling as much as 3 percent of their total tuition revenue. The new law gradually increases EIU's limit to 10 percent through 2016. Students who qualify financially and academically are eligible for the \$2,500 waivers each year.

EIU enters dual-degree agreements with universities in China, Korea. Luo Aiping, chairman of Hankou University in China, recently visited EIU to sign a Cooperation Agreement on the Undergraduate Education Project of Business Administration with EIU. The agreement will allow 15 to 20 undergraduates from Hankou University to complete two years of study there and then continue their studies in English for 2.5 years at EIU. Upon completion of both institutions' standard requirements, students will be issued dual degrees in business administration -- one from Hankou University and the other from EIU. The agreement also permits opportunities for study abroad for domestic students and visiting faculty exchanges. This is EIU's second Dual Degree Memorandum of Understanding; the first, also initiated this year, is with Chungnam National University in the Republic of Korea. Having dual-degree programs -- a highly desired and prestigious form of international education -- aligns Eastern with the most advanced forms of international collaborations.

School of Business maintains AACSB accreditation. The School of Business has maintained its business and accounting accreditation by AACSB International (Association to Advance Collegiate Schools of Business). AACSB accreditation is the mark of quality distinction most widely sought after by business schools. Founded in 1916, AACSB International is the longest serving global accrediting body for business schools that offer undergraduate, master's and doctoral degrees in business and accounting. Only 633 schools of business, or less than 5 percent worldwide, have earned this distinguished hallmark of excellence in management education. Only 177 of those have earned specialized accreditation for their accounting programs.

Urban Prep students visit EIU. EIU recently hosted the second-annual senior class retreat for Urban Prep Academy for Young Men in Englewood. Urban Prep Academy -- Chicago's only public all-male, all-African-American high school -- opened in 2006, and both of the classes that have graduated in that time have had a 100 percent college acceptance rate; some of those students are now attending EIU. During their EIU retreat, Urban Prep seniors stayed overnight in residence halls, sat in on classes, toured campus, heard from speakers and more.

Project Hero shows EIU's support for military members. Nearly 870 U.S. military members received care packages from Project Hero, an effort spearheaded by Michael Ruybal, EIU's veterans service coordinator. Each bag contained a U.S. flag; donated items; and brief notes from members of the EIU community to thank recipients for their service, as well as welcome them to consider attending Eastern. "We're letting them know that Eastern supports them while they're out in the field and that we'll continue to support them here in our community," Ruybal said.

President Perry starts blog. President Bill Perry has launched a new means of communication with the friends and community of EIU. "My 'Eastern Ways' blog is one way I will informally notify you of the ways EIU values and supports excellence, personal relationships, service, and opportunity," he writes. "Within this blog, you'll hear about examples of EIU students, faculty and staff getting involved in academic programs, student life, and community engagement. I hope the things you read here will motivate you to learn more about EIU, where we expect greatness of ourselves in our mission to provide a second-to-none higher education." STUDENT SPOTLIGHT

New EIU students gather for community service. More than 1,900 new EIU students helped with more than 40 community-service projects as part of EIU's third annual JumpStart 2 G.I.V.E. event the weekend before classes began. Before heading out to volunteer, the students met on the Library Quad for a discussion on social issues. The event is part of a series of activities that is designed to encourage new students to become active citizens of the university, local and global communities.

FACULTY/STAFF NEWS

Smith named Faculty Laureate. Due in part to his ability to instill excitement and enthusiasm into reluctant learners, history professor David Smith is EIU's 2011-2012 Faculty Laureate, the university's official spokesperson on the importance of a general/liberal education. He delivered the keynote speech at Convocation, a welcoming ceremony for incoming students. Smith said his mission is not to teach students what to think about the past, but, rather, how to think about the past. "He is able to teach history in such a way that not only keeps students' attention but, whether they know it or not, subtly imparts deeper aspects on history and historiography that they might not be able to grasp otherwise," said former student Ian Nelk.

Henderson named assistant VP for academic affairs for technology. John G. Henderson has accepted the appointment of assistant vice president for academic affairs for technology, a position he has held on an interim basis since November 2010. Henderson, who came to Eastern as director of User Services in 1998, has also served as acting director of Client Services and director of Instructional Technology Support Services for CATS (Center for Academic Technology Support).

Lanham leads state library organization. Allen Lanham, dean of Library Services, is serving as chair of the Consortium of Academic and Research Libraries in Illinois' Board of Directors as part of his one-year term representing public universities.

G. University Highlights (Cont.)

Journalism professor wins award for motorcycle trip to Arctic Circle. Journalism professor Brian Poulter has been honored for the in-class benefit of his 10,000-mile solo motorcycle trip to the Arctic Circle. Poulter received the 2011 Scholarship of Application award from the Small Programs Interest Group of the Association for Education in Journalism and Mass Communication. Poulter, a photojournalist who has taught at EIU since 1992, uses photos and notes from the June 2010 trip in his classes. "I ask students to solve the same technical, journalistic and aesthetic problems I had to face in the field, under the same ultra-tight deadlines I faced," Poulter said. This past summer, Poulter took a similar motorcycle trip along the Oregon Trail.

Dean Hanner retires. Mary Anne Hanner's retirement ended a phase of her EIU affiliation that has included earning two EIU degrees, teaching as a faculty member, and ultimately serving as dean of the College of Sciences. "During her 10-plus years in the COS dean's office, Dr. Hanner effectively promoted the quality of her college, advanced its programs, managed its substantial budget during difficult times, solved personnel challenges, and gave wise and thoughtful counsel to me and her colleague deans," Lord said. Hanner '72, '74, who began her career as a K-12 speech-language pathologist, co-authored the widely used Language Processing Test with EIU colleague Gail Richard in 1985. She has performed extensive committee work at the state and national levels. She continues to serve as a reaccreditation site visitor for the American Speech-Language Hearing Association, while also continuing to provide independent accreditation consulting services.

ALUMNI ACTIVITIES

Davis honored as pioneer in genetics research. Due to struggling with a form of dyslexia, Ronald W. Davis '64 was encouraged by a high school counselor to avoid science classes. He ignored that advice and went on to complete requirements for four majors (chemistry, physics, math and botany) in four years at EIU. Now, Davis is a Stanford University professor known as a pioneer in molecular genetics and genomics. He will receive the 2011 Gruber Genetics Prize, including \$500,000, for his groundbreaking work. Yarcho is conductor for national tour of 'Wicked.' Jason Yarcho '05 has garnered rave reviews as the conductor for the national touring production of the hit Broadway show "Wicked." Yarcho served as the show's assistant conductor for about a year before taking the top spot about three years ago.

Messmore named acting director of Illinois Department of Insurance. Jack Messmore '74 has been appointed acting director for the Illinois Department of Insurance. Messmore, who has been with the DOI for 25 years, has more than 35 years of management and regulatory experience in the public and private sectors.

MedCity Media changing the face of online health-care news. Chris Seper '95, '97 has been changing the way health-care news is published online since he founded MedCity Media two years ago. The company offers customized health-related content for organizations. The booming company now has offices in three major medical cities: Cleveland, the Twin Cities in Minnesota, and Research Triangle Park in North Carolina. Seper was previously an award-winning reporter for The Plain Dealer, Philadelphia Inquirer, The Washington Post and Christian Science Monitor. Seper was named one of EIU's Outstanding Graduate Alumni as part of the Graduate School's 50th anniversary celebration in 2005.

Hearing-impaired author's book focuses on treasures of ordinary sounds. The progressive hearing loss Marsha Engle '80 has experienced since childhood has rendered her unable to hear many sounds she used to enjoy. Her realization that images could bring back memories of what she used to hear led her to compile the book "100 Sounds to See." The book, featuring photography by William Huber, "brings a unique and wondrous perspective" to the challenges faced by the hearing-impaired community, wrote the American Academy of Audiology Foundation. Johnson apparently youngest superintendent in Illinois. At age 28, Crystal Johnson '09, '10, superintendent of the Rossville-Alvin school district, appears to be the youngest school chief in Illinois. Johnson, who also retains her previous position as K-8 principal, once served as the district's athletic director and assistant superintendent. She also previously taught special education classes in the East Peoria school district and at Pekin High School.

FOCUS ON ATHLETICS

Panthers win first Mid-America Classic traveling trophy. Rivals EIU and Illinois State met up for the 100th playing of the Mid-America Classic -- and Coach Bob Spoo's final year at the helm -- at the football season opener on Sept. 1. This year's game included the addition of the Mid-America Classic traveling trophy, which will make its first home at EIU thanks to the Panthers' 33-26 win over the Redbirds.

Student-athletes earn OVC academic recognition. Thirty-two EIU student-athletes were included on the Ohio Valley Conference Medal of Honor list for posting a 4.00 GPA for the academic year, giving EIU the highest total of any school in the OVC. In addition, EIU had 140 student-athletes -- also the highest total in the conference -- listed on the OVC Commissioner's Honor Roll, which recognizes student-athletes with a GPA of 3.25 or higher.

Athletes participate in first Walk of Champions. The EIU athletic department welcomed its student-athletes back to campus with a cookout followed by the new Walk of Champions, in which student-athletes donned Walk of Champions T-shirts and marched through campus to take part in EIU's First Night activities on the South Quad. Speakers included President Bill Perry, Athletic Director Barbara Burke, football coach Bob Spoo and senior linebacker Cory Leman.
