Course Practical experience in supervised clinical settings with an emphasis on the application of administration and leadership skills. This course will also allow

for a continuation of the student's opportunity to synthesize their knowledge and skills of previously taught clinical proficiencies and competencies. This course will be taken concurrently with KSS 3144.

Objectives: At the end of the course the student will be able to:

- 1. Apply clinical skills that demonstrate a working knowledge of the administrative processes associated with the Athletic Training profession.
- **2.** Apply clinical skills that demonstrate a working knowledge of budget processes in various Athletic Training workplace settings.
- **3.** Synthesize knowledge and clinical skills in various Athletic Training settings at a level equivalent to an entry level position for a recent university graduate with a Bachelor's degree.
- **4.** Demonstrate proficiency in clinical skills and knowledge equivalent to an entry level professional in the field of athletic training.

sharpened prior to sitting for the National Board Exam. A clinical skill assessment packet covering these skills will be provided to you. **YOU**

Clinical: Student need to attain approximately 20 hours of weekly clinical

experience in the EIU ATEP clinical sites. You are <u>not</u> to provide any treatment or rehabilitation until you have successfully completed the appropriate skill requirements and have permission of an ACI. You are not to evaluate, treat or provide advice to any athletes outside of the athletic training clinical site. Refer to clinical skill packet VI for additional information regarding your clinical experience. Students need

to submit weekly reflection of clinical experiences. *Reflections are to be submitted each Monday by 12:00 pm*. Reflection guidelines will be discussed in class.
