#### **Course Description:**

Overview of the politics and administration of various sports organizations and areas of sports activity.

## **Course Objectives:**

- 1. Students will analyze the differences in focus between various areas of sport for example the difference between community, intercollegiate and professional sport
- 2. Students will examine the primary governance structures and administrative bodies overseeing the various areas of sport for example the AAU, IOC, NCAA and NAIA.
- 3. Students will evaluate current policy issues across the various areas of sport examples include drug testing, safety, and eligibility requirements.
- 4. Students will analyze the positions and actions of competing interests in the formation of policy across various areas of sport examples include the actors involved with the NCAA mascot decision, and the ongoing struggle to create policy in collective bargaining settings.

#### **Assignments:**

**Readings: The readings will be required to be successful in this course.** Reading is a crucial requirement to discussion and participation in this course.

Quizzes/In Class Assignments: Quizzes will vary in length and will be 30% of your grade. If the instructor notices that students are not coming prepared to class, then quizzes will be assigned on a weekly basis. If material is read, then in class assignments will be used to analyze and further explore our knowledge regarding the material.

Round Table Assignments: There will be Round Table Assignments each week of class. To assist students in thinking critically about the material that is being read throughout the term, for the first 14 weeks of the course, students will be asked to complete a round table assignment. Students are asked to post their article at least 48 hour prior to class in the discussion board so that the class may read their article. These assignments help to ensure students have read the material and can connect the material to outside resources. These assignments also are designed to assist students in taking ownership of their learning and to encourage every student to become a self-directed learner. In 2-4 pages (double spaced), students will do the following:

- Find and summarize a scholarly article that explores the governance issue discussed in the readings \*if possible, students should provide a link to the article or post the article along with their round table assignment on D2L
- What was interesting about the article?
- How can sport managers and policy makers use this information?
- Provide at least 3 questions for discussion- (Please give your classmates something to work with. They are
  graded on their responses, and if solid question is not provided, it is difficult to provide a solid answer.) Each
  student will be required to bring their answers to the class in which the article is discussed. Answers must be
  thorough and discuss the article and bring in outside examples.

Students are asked to write using APA format (in-text citations as well as references), including use subheadings for this assignment (i.e. summary of article, interesting facts, discussion questions) and students should post their assignment to the discussion board for their peers to review. Please note, you should try and find a scholarly article, however, there are a lot of interesting articles in the news that reflect governance in sports, (hence, the use of my Runners World Source for this Course). So you should try and find a source that best suits the topic you are researching. However, if you choose a <u>nonscholarly article, I EXPECT that you research the current policy</u>. For example, if you find an article regarding drug testing, what does the IOC, WADA, NCAA, IHSA, state about drug testing? There are a lot of current topics out there so this could make this class more interesting, but remember, you are a graduate student, so please use APA format, and clean language. Also avoid text type of language such as LOL, etc.

## **Discussion:**

#### **Discussion in class:**

After a student has posted his/her round table assignment to the class, each member of the class will be expected to participate in a lively discussion regarding the reading. They should have thought how the article applies to real life and other situations within sport. The Round Table leader will be responsible for leading the discussion for the portion of the class.

This assignment requires students to read their peers round table articles in order for them to write an articulated indepth response to their peer's discussion questions. Comments should not simply be based on student's opinions, students are asked to back up their reasoning with facts from the round table assignments and/or from readings. Responses should not simply be one word answers, but should be in-depth and warrant further discussion from other students.

## **Final Research Paper**

In recent years, there have been several governance/policy issues in sport that have been given national/international attention. This is your chance to apply the information that you have learned or the information that you want to learn more about and pick a topic that is most interesting to you. Policies are cut and dry, but many times those that carry out those policies have not carried them through as such. You may discuss topics that we did not cover such as Title IX, violence, substance abuse, safety, the possibilities are endless. If you took my undergraduate class, this should be a more in depth topic regarding an issue that interests you. Using a governance lens and referring to the textbook chapters, and articles, as well as the scholarly articles that the students have read throughout the semester, students are asked to write a paper about their topic:

- Describe the Issue and the policies that are accompanying it (specifically focusing on the governance issues)
- Is this a controversial topic? If not, it is okay but generally policies are instilled to keep order but it doesn't mean that everyone is happy. Describe the how it affects the stakeholders involved.
- How has your issue, or policy impacted strategic management, policy development, ethics in sport, and intercollegiate athletics in regards to sport governance?
- As a sport administrator, how would you have handled the situation (this is the only section of your paper that you may write in the first person)
- Length should be at least 8-10 pages.
- Please include at least 6-8 references in this paper, cited correctly. 1 inch margins, cover page etc.

Remember, this assignment should use APA style (meaning a cover page/reference page) and should be submitted to the designated dropbox by the due date).

#### Presentation:

You will present your findings of your research paper through a formal presentation during the final time. The presentation will be graded through the KSS oral rubric for Graduate students.

**Grading of Written Assignments:** Each assignment will be graded in accordance to the suggested KSS rubric for writing for graduate students.

#### **Extra Credit**

Extra Credit may be given throughout the semester if it will improve your professional experiences and "toolbox." Opportunities such as professional conferences and volunteering (excluding internship opportunities) for sporting events may be used as such. A written summary of one page will also be required to describe your experience. Only three extra credit opportunities will be given per student, however, you should always continue to grow as a young professional.
