#### Do newly elected officials have to complete Open Meetings Act training?

Yes, all newly elected officials are required to complete an electronic training curriculum on the Open Meetings Act within 90 days of taking the oath of office or assuming their duties as a member of a public body. The training curriculum was developed by the Public Access Counselor of the Illinois Attorney General's office, and can be accessed on the Public Access Counselor's website using this link. After completing the training, the newly elected official must file a copy of the certificate of completion with the public body. Newly appointed officers who serve on commissions and boards such as the Zoning Board of Appeals, Plan Commission, etc., also need to complete the training.

This week's *Statehouse Briefing* provides media coverage of pension consolidation, legislation that Governor Bruce Rauner has signed or vetoed and IML's comments on the new Federal Rural Broadband Program.

# IML Emphasizes the Need to Consolidate Public Safety Pension Funds

On Friday, August 24, IML Executive Director Brad Cole joined WJPF's Tom Miller on the 1020 AM Morning Newswatch to discuss the need to reform our public safety pension system to relieve the financial pressure on municipalities and taxpayers. Listen to the entire radio interview via this link.

As an example, Cole highlighted that in FY 2000, the City of Carbondale's property tax levy was just over \$1 million and pension contributions were \$727,000. Today, the property tax levy has barely increased and still sits around \$1 million, while the city's pension contributions are nearly \$3.5 million.

IML has proposed six different options to consolidate public safety pension funds to lower costs and improve investment returns. Those proposals are available on our website (<u>linked here for your convenience</u>).

# Legislation Signed Permitting Waiver of Annual Medical Evaluation for PTSD

On Sunday, August 26, the Governor signed <u>SB 3119 (Sen. Pamela Althoff, R-McHenry/Rep. Michael</u> Zalewski, D-Riverside).

The new law permits certain firefighters diagnosed with post-traumatic stress disorder (PTSD) related to their service to apply for a waiver from the annual medical exam required to maintain their disability pension award. To receive this waiver, four out of five members of the local pension board must vote to approve the request.

IML opposed this legislation citing the precedent this could set in future disability pension determinations.

The bill also amends the Illinois Municipal Retirement Fund (IMRF) Article of the Illinois Pension Code to provide that a person who participated as a chief of police in a fund under the Downstate Police Article and returns to work in any capacity with the police department in the same municipality is not considered an employee under the IMRF Article. The bill limits the application of the provisions to

persons who were not participating employees before the effective date of the amendatory Act. IML did not object to this provision.

The new law went into effect immediately.

# Governor Signs Legislation Regarding Investigation of Officer-Involved Shootings

On Sunday, August 19, Governor Rauner signed <u>SB 2378 (Sen. Kwame Raoul, D-Chicago/Rep. John</u> <u>Cabello, R-Machesney Park</u>). The new law requires each law enforcement agency to adopt a written policy on how to handle internal reviews of officer-involved shootings.

This required policy must include that each law enforcement officer shall immediately report any officerinvolved shooting to the appropriate supervisor, and that each agency shall conduct a thorough review of the circumstances of the shooting. Each policy must be available for copying and inspection under the Freedom of Information Act.

The new law goes into effect on January 1, 2019.

# Legislation Reforming Fees, Fines and Assessment Structure Signed Into Law

Legislation significantly changing the way court fees, fines and assessments are handled was signed into law by the Governor on Monday, August 20.

<u>HB 4594 (Rep. Steve Andersson, R-Geneva/Sen. John Mulroe, D-Chicago)</u> is based on the 2016 Statutory Court Fee Task Force Report (<u>available via this link</u>) issued on June 1, 2016. The report addressed four key findings:

- 1. The nature and purpose of assessments have changed over time.
- 2. Court fines and fees are constantly increasing and outpacing inflation.
- 3. There is excessive variation of fees, fines and assessments throughout the state.
- 4. The fees impose a severe and disproportionate impact on low- and moderate-income Illinois residents.

IML tracked and repeatedly inquired about the financial impact this legislation could have on municipalities. The sponsors and advocates in favor of this legislation were unable to provide comprehensive information about the new law's financial impact. IML will strive to understand the full impact this legislation will have on our members and will work with the General Assembly to make any necessary changes to the new law.

The new law goes into effect on July 1, 2019, and is set to be repealed on January 1, 2021.

# Illinois Service Member Employment and Reemployment Rights Act Signed into Law

On Sunday, August 26, <u>SB 3547 (Sen. Thomas Cullerton, D-Villa Park/Rep. Linda Chapa LaVia, D-Aurora)</u> was signed into law by the Governor.

The new law seeks to consolidate and modernize Illinois statutes regarding employment protections for Illinois' military service members. It expands protections with respect to performance review requirements, military employment rights notice requirements and basic reemployment protections for federally recognized auxiliaries during emergencies.

The new law goes into effect on January 1, 2019.

# **Governor Vetoes Paramedic Legislation**

On Tuesday, August 21, the Governor vetoed the third and final piece of legislation (<u>HB 5221 - Rep.</u> <u>Kathleen Willis, D-Addison/Sen. Linda Holmes, D-Aurora</u>) attempting to expand certain benefits for firefighters to paramedics. HB 5221 would have changed the definition of firefighter in the Public Employee Disability Act (PEDA) to include paramedics. The Governor, in his veto message, stated that this proposal would operate as an unfunded state mandate on local governments. This proposal was in addition to HB 126 and 127, highlighted in the <u>August 20 edition of the Statehouse Briefing (linked here)</u>, which were vetoed on Sunday, August 19. IML opposed all three pieces of legislation and <u>sent a letter to the Governor, linked here</u>, requesting his veto on all three proposals.

The General Assembly will have the opportunity to override the Governor's vetoes during their fall veto session, which is scheduled to start on Tuesday, November 13.

# IML Submits Comments on Federal Rural Broadband Program

IML will soon submit comments on a new Rural Broadband Pilot Program, highlighted in the August edition of the *Federal Focus* (linked here for your convenience). Those comments addressed questions of what should be considered when determining sufficient access, how data speeds should be verified and how applications should be evaluated.

# What is Constitution Day?

Sunday, August 26, 2018, is the first significant anniversary of the Illinois Bicentennial Celebration. On that day 200 years ago, the state's first constitution was signed. As we celebrate, we reflect on why we are **#IllinoisProud**.

"Two hundred years ago, thirty-three delegates stood shoulder-to-shoulder with a cheering crowd in Kaskaskia, Illinois. The flag of the United States flew in the late summer breeze, as militia officers readied a cannon and fired a twenty-gun salute, paused for a moment, then fired one more in recognition of the soon-to-be state of Illinois. Illinois did not officially become a state when the delegates signed the first constitution, but it reached an important milestone on its path toward statehood.

History is often measured in terms of progress and Illinois history is certainly no exception. The Constitution of 1818 remained the law of the land in Illinois for just thirty years. Increases in population, technology, and the economy led citizens 'Born, Built, and Grown' in Illinois to form new constitutions in 1848, 1870, and 1970. In many ways, these constitutions serve as mile markers on Illinois' road toward greater freedom and equality."

Dr. Samuel Wheeler, is the tenth state historian in Illinois History and a Bicentennial Commissioner. He penned an op-ed about Illinois Constitution Day. For the full editorial, <u>click here</u>.
