Where We Are Now

Dear EIUAA Members.

Your EIUAA Board of Directors hopes that you have had a great summer! We continue to work on your behalf at Eastern, in Coles County, and in the state of Illinois.

Update on Health Insurance

The Illinois Supreme Court, in considering the Kanerva lawsuit, ruled in July that state-subsidized health insurance is a protected pension benefit and that the state cannot charge premiums for it. On August 28, a Sangamon County Court

upheld that ruling and stated that state government retirees will no longer have health insurance premiums deducted from their paychecks. Deductions should stop for checks going out October 1 and later.

Millions of dollars in insurance premiums have been paid by retirees since July 1, 2013. Although CMS is holding those dollars in an escrow account, SURS does not know how or when the insurance premiums will be returned to annuitants. As additional information becomes available, we will share it with you.

Retirees Review Health Insurance Options

CMS Meeting Will Answer Questions on October 22

"What can we predict from the recent Supreme Court decision?"

"Will the state health insurance plan change this fall?"

"Why do some counties get fewer options than others?"

These are just a few of the questions raised by retirees in a summer 2014 health insurance survey by the University Professionals of Illinois (UPI). The survey asked retirees about their current health insurance, positive and negative experiences, questions, and concerns.

Some results of the survey: Of the 144 retirees who responded, more than 4/5 had signed up for health insurance through the State Medicare Advantage Program (TRAIL) rather than "opt out" and buy supplementary coverage from a private company. Within the state program, over 9/10 chose United Health Care PPO. In most cases, they chose this Preferred Provider Option (PPO) to avoid out-of-network costs while staying with their current doctors or finding doctors out of state.

One retiree said his doctors had complained of excessive paperwork in dealing with United. Another said his doctor would not accept United. One person noted that United had reclassified some medications as non-maintenance, so these medications were more costly to him; he said United had also reclassified other drugs as Medicare, so these drugs were not eligible for a pharmacy's incentive program.

Despite complaints, more than 4/5 (86%) of those who responded to the survey

said they did not expect to change providers during the next Benefit Change Period, and more than 2/3 (69%) said the recent Supreme Court decision would not change their minds.

To address retirees' questions about their health insurance options, CMS will hold an informational meeting on Wednesday, October 22, from 9:30-11:30 a.m.at Unique Suites in Charleston. The featured speaker will be Pam Kogler, CMS deputy director for health insurance. Also present to answer questions will be representatives of Coventry HMO and United Health Care PPO.

Jill Nilsen, in her role as legislative chair of EIUAA, has provided answers in this newsletter about recent Supreme Court decisions on retiree health insurance.

A sampling of retiree questions about health insurance:

- What are the chances of returning to Health Alliance as we knew it?
- Can out-of-staters get more than one PPO?
- Is there an out-of-pocket maximum for drug costs?
- If the courts rule that the state must pay for our health insurance, will we be reimbursed the money we've been paying? If so, when?
- What are my enrollment choices, including prescription drug plan choices?

Are my premiums taken out of my Social Security or my SURS pension?

Update on Pension Reform Legislation

A Sangamon court judge said in September that a recent Illinois Supreme Court decision on state retiree health insurance is a factor in the lawsuits filed to overturn pension reform. Circuit Judge John Belz said the pension reform cases should be finalized by the end of the year. The next hearing is scheduled for October 8, 2014. It was originally believed that any ruling on the pension reform legislation would take from 18 - 24 months.

One of the lawyers representing retirees, John Fitzgerald, said, "This confirms what we have been saying for a long time, which is that Kanerva is in many ways a game changer."

The case will be heard first in circuit court, then referred to the Illinois Supreme Court. It may get there much more quickly than originally thought. EIUAA will keep you informed as information is available to us.

EIU Presidential Search

President Bill Perry will retire from EIU's presidency on June 30, 2015. The Board of Trustees has hired a search consultant from Korn-Ferry, a national higher education search firm, and has identified a search committee to recommend a group of finalists for the position to the Board. Your EIUAA has a voice on the Presidential Search Advisory Committee, the first time such an opportunity has been provided. The preliminary timeline would schedule off-campus interviews with 10–12 finalists by the end of November and would schedule on-campus interviews by the middle of January. A job description will be finalized by the beginning of October. As always, we will keep you informed of the status of the search via the EIUAA listserv.
