### Governor Rauner's Proposed Budget Causes Distress!

With just a little over a month in office, Governor Rauner's budget address caused many retirees and SUAA members to sit up straight, wide-eyed, and just plain gasp. We were able to identify areas of the proposed budget that just did not make sense. It became quite apparent that the Governor's advisors and staff have not been paying attention to the Kanerva lawsuit or even the pension lawsuit. To everyone's dismay, these advisors do not seem to be knowledgeable about state health Insurance, the Community College Insurance Plan, any of the pension systems, or even what the protection clause of the Illinois Constitution means. But then again, how could they, with so little time in their positions? The governor was on time with his proposed budget and his address, but the key word is "proposed." Nothing is directly legislated from this

### Assistance With Daily Living Some Low-Cost Programs

A t EIUAA's February 26 meeting, speakers presented options for people who need some type of assistance with daily living, either at home or in a residential setting. Community Care Systems of Illinois (CCSI) helps caregivers and families in the home. Supportive Living offers apartments with services, a lowcost alternative to nursing home care.

For people who need assistance while living at home, CCSI's Community Care Program offers assistance with daily living: meal preparation, money management, transportation, help with personal care, and other services. Community Care can also arrange for emergency home response services and adult day care. These services are currently offered at no cost to people who are at least 60 and have an income below \$17,000, with less than \$35,000 in assets (not including home and car).

Through another CCSI program, Case Managers assess a person's needs, set goals for care, make referrals for services (medical, legal, transportation, etc.), and monitor the person's well-being. CCSI also offers screening services to prove eligibility for nursing home or assistive living placement. Recipients need not meet income standards.

A third program, the CCSI Caregiver Advisor Program, offers support to all caregivers, including grandparents raising grandchildren. This program provides information, a newsletter, home visits, support groups, and referrals for services such as counseling, rides, money management, and assistance with insurance claims. For caregivers who become ill or just need a break, the program also offers respite care. Participants need not meet income standards.

CCSI is a part of Illinois' Family Caregiver Program, funded through the Illinois Department on Aging (IDOA). For further information, call 217-774-7885.

For seniors (age 65 and up) who find living at home "difficult, isolating, or dangerous," Supportive Living Illinois combines apartment-style housing with services (meals, transportation,

etc.) like those of traditional assisted living. However, the program has lower costs due to Medicaid funding. Applicants must meet health requirements, including the ability to participate in their own care, and income requirements. Charleston-area residents who would like further information or a tour are welcome to call Heritage Woods at 345-4900. budget. Tough negotiations lie ahead for us, but we must concentrate on what is do-able. Education for both the Governor and his staff will be a key factor for us going forward. Several legislators will also need a refresher course.

The Supreme Court will hear the oral argument regarding pension reform litigation on Wednesday, March 11, 2015 at 2:30 p.m. SUAA attorney Aaron Maduff of Maduff & Maduff, LLC, will argue orally on this date. There will be a live internet stream. Please mark this date, as it will be considered a historic lawsuit and it affects both participants and beneficiaries of the state funded pension systems. We look for the Governor to be present, as it seems it would be most beneficial for him to hear the oral arguments. The Supreme Court's decision will most likely be known in April.

It is imperative for the SUAA audience to participate in this political game change. Each and every one of us can make a difference. State supported universities could be hit with a 31.5% funding loss. SURS could be hit with a funding loss. This is not the time to be complacent, as these hard hits could even be detrimental to your community. Stay informed as we gear up for another round. It is the new 99th General Assembly, with a whole new dimension.
