Comments:

Even though the program is accredited, the Department of Art + Design has chosen to employ the template in addition to providing accreditation information, because they feel the table provides useful tracking and data for SLO application, and we of course agree. The initial assessment plan of 2020 lacked SLOs, so comparison here is not possible—but, we are happy to see that well-crafted, measurable SLOs have been created and seem to have demonstrated their measurability via this data report. One overarching suggestion for future data tables would be also to include the percentages of students expected to meet the targets specified in any given year. For example, for SLO #1, give a target percentage of students expected in any given academic year to meet juror expectations for inclusion in the student exhibition. That way, it is easy to sync target to results—you can say "we expected [number] to meet the target; in 2 years we saw [number] actually meet it." The technique will help you all track the overall progress of the assessment plan, and make feeding back the results into the curriculum and instructional methods easier. We do note that "improvements and changes" section indicate that your curriculum development is sensitive to assessment results, so that of course is a good thing.

The NASAD accreditor is scheduled to visit in the spring of 2023, so no doubt the visit results will inform your assessment methods and curriculum. Based on this well-designed approach you chronicle here, we fully expect the visit to be a success.

Academic Affairs – Review & Feedback B.A. Art (accredited)

The B.A. in Art program has added a 1-credit course, ART 1749 Creative Practices, to its curriculum in an effort to better prepare students for growth within the Art major. The years-long individual portfolio will ensure continual assessment throughout the program. While the Art program as a whole prepares for the accreditation review by the National Association of Schools of Art and Design (NASAD), the program has continued to mentor and train students to prepare their artworks to meet professional standards. 95 of 165 student artwork submissions were accepted by professional jurors for inclusion in the All Student Art Exhibition, with 26 of the 95 meriting awards. The program will want to ensure regular meetings, as needed, for addressing ways to improve methods for making practical use of data such as award criteria met.

Improvements and Changes Based on Assessment

1. Provide a short summary (1-2 paragraphs or bullets) of any curricular actions (revisions, additions, and so on) that were approved over the past four years as a result of reflecting on the student learning outcomes data. Are there any additional future changes, revisions, or interventions proposed or still pending?

We added a 1 credit hour course, Art 1749 Creative Practices, to all of our undergraduate majors. Art + Design students routinely enter the Department with markedly different skill levels, research habits, and conceptual frameworks. These essential traits form the core of a successful creative practice, and in an effort to reduce disparities among incoming students and establish consistency in pedagogical approach, the Foundations Committee has discussed the need for a course that specifically addresses these issues. This creative practices prep-class is designed to instill good work habits, productive attitudes, and effective research strategies at the foundations level, aiming to calibrate and elevate the working methods of incoming students. Foregrounding these skills at the foundations level will accelerate growth toward independent research, creative thinking, idea generation, and best practices that compound as students matriculate into discipline-specific and upper-level studio courses. Students will create and compile a binder of information from this class that they will continue to use and build upon in their subsequent courses. This new course Art 1749 was approved on February 2, 2022 by EIU's College of Liberal Arts and Sciences Curriculum Committee to be effective Fall 2022. The proposal was then granted approval at EIU by the Council of Academic Affairs at its meeting on March 3, 2022.

We have held off from developing/implementing any future revisions until our NASAD re-accreditation is completed in Spring 2023. It is hoped that this process will clarify the best practices going forward.

It should also be noted that most of the assessment in a studio environment comes from a holistic approach. Through continual peer and professor-driven crits and exhibitions including the Annual Undergraduate Exhibition, we are able to assess their integrative progress on an ongoing basis. This continual assessment is reinforced through Sophomore Portfolio Review and Art 4749 Senior Portfolio, both of which were established in 2018. Art Education similarly uses multiple summative rubrics for assignments including papers, presentations, art works and curriculum projects; these instruments are supplemented by regular check-ins and performance review meetings.

In AY21 -22, 95 artworks met juror's expectation for inclusion in All Student Art exhibition; 26 of 95 artworks in exhibition received awards for artwork in exhibition. 165 works were submitted for the show and 95 were accepted. The Annual Spring show is juried by three outside professionals in the field of Art + Design. In a previous year, the following criteria was listed by the jurors to indicate the process of evaluation. Our criteria for selecting Award, Merit, and Honorable Mentions were the following:

- High level of skills in design, rendering, and working with materials
- Expression and originality
- Visual impact of the piece
- Development of concept/idea in a single work or series
- Creative experimentation and risk-taking
- Evidence of passion and commitment invested in the finished work

These reviews have resulted in observed improvements in student learning. We have admired their passion and perseverance throughout the difficult pandemic years.
