# Standard I. Eastern students observe the highest principles of academic integrity and support a campus environment conducive to scholarship.

## Violations of this standard:

- a. Conduct in subversion of academic standards, such as cheating, *plagiarism*, collusion, misrepresentation, or falsification of data regardless of source on any course assignment.
- b. Theft or the unauthorized possession of examination items; alteration, theft, or destruction of the academic work of others, or academic records, library materials, laboratory materials, or other University equipment or property related to instructional matters or research.
- c. Submitting work previously presented in another course unless specifically permitted by the instructor.
- d. Conduct which disrupts the academic environment; which includes disruption in a classroom, faculty office, lab, studio, library or learning environment (including an online learning system)
- e. Complicity with others in violations of this standard.

The following request was approved by executive action at the CLAS Curriculum Committee meeting on Sep 6, 2023. I ask that similar action be taken at the Council on Graduate Studies.

### **Request:**

Add the statement – "This course is restricted to Graduate students in Mathematics and Mathematics Education" to the prerequisite of *MAT 5700 – Topics in Teaching Mathematics*.

## **Rationale:**

The course MAT 5700 is clearly intended for graduate and post-bac students who have a background in teaching mathematics. However, the current course description leaves open the possibility for students without the proper background to enroll in the class. By adding this one sentence to the course prerequisite, it will be clear the intent of the course and prevent nonqualified students from enrolling.

**MAT 5700 - Topics in Teaching Mathematics.** (Arr.-Arr.-2 to 4) Study of problems which arise in teaching secondary mathematics, research in mathematics education; assigned reading reports. **Prerequisites & Notes:** Experience teaching grades six through twelve. May be repeated for a maximum of nine semester hours credit. Credits: 2 to 4

### **Proposed**

MAT 5700 - Topics in Teaching Mathematics. (Arr.-Arr.-2 to 4) Study of problems which arise in teaching secondary mathematics, research in mathematics education; assigned reading reports. Prerequisites & Notes: Experience teaching grades six through twelve. May be repeated for a maximum of nine semester hours credit. This course is restricted to Graduate students in Mathematics and Mathematics Education. Credits: 2 to 4

The following request was approved by executive action at the CLAS Curriculum Committee meeting on Sep 6, 2023. I ask that similar action be taken at the Council on Graduate Studies.

## **Request:**

Change the prerequisite for *CSM* 4970 – *Principles of Operating Systems* to require a grade of 'C' or better in CSM 3870.

## **Rationale:**

Many operating system concepts, such as memory management, process scheduling, file systems, and synchronization mechanisms, are based on fundamental data structures such as queues, stacks, trees, graphs, and hash tables. For example, hash tables are used to implement file systems, directory structures, and caching mechanisms in the operating system. The Linux scheduler keeps a red-black tree of all runnable processes for efficient deletions and insertions. Many algorithms used in operating systems rely on data structures. For example, page replacement algorithms typically use a queue or a linked list to keep track of the most recently used pages. These are just a few examples of the use of data structures in operating systems. Therefore, a prerequisite of data structures for the operating systems course is essential to ensure that students have the necessary foundation to understand and apply the concepts covered in the course effectively and allow science students to more easily pursue a second major or a minor in mathematics.
