Subject: Catalog revisions for compliance with SB 49

In 2022 the Illinois State Legislature passed Public Act <u>102-0998</u> which, under certain circumstances, requires universities to release transcripts to students with a financial hold and provides additional provisions for withdraw from the university. In 2023 the Illinois State Legislature passed <u>Public Act 103-0054</u> which amends Public Act 102-0998 by expanding the options available to students to receive an official transcript regardless of hold status. In addition, beginning 7/1/24, <u>federal regulations</u> will require any institution receiving federal financial aid to release a student's transcript if the course credits were paid for with federal financial aid. Finally, the President's Council amended <u>IGP 64</u> and <u>IGP 66</u> to comply with these regulations. In response, I am proposing the following revisions to language in our graduate catalog.

The Records Office will make a transcript of the academic record of a student when requested to do so. All requests for transcripts must be in writing, either by letter or on the request form supplied by the Records Office or at the above web site. A fee is charged for each transcript issued. Transcripts will be issued only for students whose records are clear. \*

**Request:** Revised mode of delivery options for CDS 5450 Graduate Seminar in CDS to include an online option as well as a face-to-face option.

**Rationale for the Request:** CDS 5450 Graduate Seminar in CDS is an approved course used as needed in the CDS graduate program. The course is currently approved as a face-to-face option only. Since the time of initial course proposal, we have developed at least one course topic that is of interest to individuals working full time or not on campus. We anticipate this course will be of interest to others outside of our specific CDS cohort and need to make an online option as well to meet the needs of these learners.

#### **Current Catalog Copy:**

(1-0-1) Study of contemporary problems, issues, trends, and developments in the field of communication disorders. Pre-requisites: Graduate degree-seeking status or permission of the department chairperson. An individual topic may be repeated once, but no more than four semester hours of credit may be earned between different seminar topics. Course will be assigned letter following course number by department to differentiate course topics A,B,D,or E.

## **Rationale:**

The existing Graduate School policy allows for the option of disqualifying a candidate for degree candidacy if they earn a grade below a B in more than 9 semester hours of graduate credit. In our experience, graduate students who earn three or more C's, especially in their first semester, do not make sufficient progress to complete their degree. Allowing such students to continue when we know degree completion is extremely unlikely does them a disservice. Therefore, we request a change in policy so graduate programs have the option to disqualify a graduate student with a grade below B in 9 or more semester hours of graduate credit.

## Existing language:

# Loss of Graduate Degree or Certificate Candidacy

- GPA: If a degree or certificate candidate in academic warning fails to return the cumulative GPA to the required 3.00 level during the next term in which he/she is enrolled, degree and/or certificate candidacy may be lost and the student may be reclassified as a non-degree graduate student. It is the candidate's responsibility to monitor the GPA.
- Grades Below B: A degree or certificate candidate receiving more than nine semester hours of graduate credit with a grade below B may be disqualified from degree or certificate candidacy and may be reclassified as a non-degree graduate student upon recommendation of the program or the Graduate School.
- Other Reasons: Academic programs may rescind degree or certificate candidacy for other reasons not specified in this catalog. It is the candidate's responsibility to be in compliance with university and program policies.
- Non-degree Requirements: Non-degree students must maintain a cumulative GPA of 2.50 or higher to continue to pursue graduate course work. It is the candidate's responsibility to monitor the GPA.

## **Proposed language:**

# Loss of Graduate Degree or Certificate Candidacy

- GPA: If a degree or certificate candidate in academic warning fails to return the cumulative GPA to the required 3.00 level during the next term in which he/she is enrolled, degree and/or certificate candidacy may be lost and the student may be reclassified as a non-degree graduate student. It is the candidate's responsibility to monitor the GPA.
- Grades Below B: A degree or certificate candidate receiving more than nine or more semester hours of graduate credit with a grade below B may be disqualified from degree or certificate candidacy and may be reclassified as a non-degree graduate student upon recommendation of the program or the Graduate School.
- Other Reasons: Academic programs may rescind degree or certificate candidacy for other reasons not specified in this catalog. It is the candidate's responsibility to be in compliance with university and program policies.
- Non-degree Requirements: Non-degree students must maintain a cumulative GPA of 2.50 or higher to continue to pursue graduate course work. It is the candidate's responsibility to monitor the GPA.

## **Additional Information:**

The current policy is discussed with KSR graduate students during their advising meetings, is included on their advising checklist, and is shared during a mandatory meeting of all KSR graduate students at the beginning of the fall semester. If this new policy were adopted we would ensure the policy is similarly shared with future graduate students. In addition, we are in the process of updating our website and would be sure to include this information with any updates.




