Fall 2012 Commencement Marshal Nomination

The Commencement Marshal carries the mace and leads the processional during commencement ceremonies. Annually, I receive many outstanding nominations and this year was no exception. Upon the nomination from Dr. Nora Pat Small, Graduate Coordinator for the Master of Arts in History Historical Administration Option, I have selected Dr. Lynne Curry, Professor of History, to serve as the Graduate School Commencement Marshal for the December 2012 Commencement Ceremonies. Dr. Curry is exemplary of the criteria for Commencement Marshal as outlined below:

- Record of Graduate Teaching: Professor Curry has an extensive history of graduate level teaching including courses in Historiography, American Civil Liberties, America Between the Wars, and Twentieth Century Social and Cultural History. Among her numerous achievements as a graduate scholar is her selection as the Rodney S. Ranes Graduate Faculty Mentor of 2011 and Faculty Laureate in 2007.
- Record of Graduate Research: Dr. Curry has an exemplary record of graduate research. She is the recipient of the Graduate Dean's Award of Excellence in Research and Creativity for 2009 and has earned Council on Faculty Research Awards in 2001, 2004, and 2009. She has published extensively in her field including two recent works that have gained significant attention and include *The DeShaney Case: Child Abuse, Family Rights, and the Dilemma of State Intervention* and *Raising Citizens in the "Century of the Child": Child-rearing and Education in the United States and Central Europe in the 20th.*
- Record of Graduate Leadership. Dr. Curry has served on the Department Graduate Committee since 2006 where she has made significant contributions that have shaped the graduate curriculum in the Department of History. She provided input valuable to the program achieving its First Choice Designation, and has been instrumental with promoting and advancing graduate research. She contributes to many other University governance groups including the University Personnel Committee, Presidents' Committee to Study Shared Governance, and the Faculty Senate where she served as Senate Chair in 2008.

Dr. Curry's record as a teacher-scholar exemplifies the ideal established by the Council on Graduate Studies for recognition as Commencement Marshal from the Graduate School and I believe this will be a fitting tribute to her record of achievement.
