II. Executive Actions

- A. ESC 1500G Change of course number, title, description and cross-list with GEG.
 - a. The Dean approved the changes. The motion to approve by Dr. New Freeland with the second of Dr. Abou-Zaid.

III. Proposals

- A. Proposal for Dual Master's Degree between Sustainable Energy and Biological Sciences 14_10_BIO_SE_Dual_MS-Degree
 - a. Discussion and vote Dr. Canam presented the proposal and highlighted the following points:
 - i. The overlap of Bio-energy and sustainable energy courses will benefit both programs.
 - ii. No new courses needed for this dual degree. All necessary courses already exist.
 - iii. There is a thesis and non-thesis option available.

The proposal was put to a vote and was unanimously approved by the committee.

- B. CDS Dr. Fahy presented on the new course proposal for CDS 5901 Advanced Diagnosis of Communication Disorders and highlighted the following points:
 - a. Will be worth 2 credit hours and requires 3 summers of on campus attendance.
 - b. A course that expands specific instruction in current processes for students without recent training on standardized and non-standardized assessments.

The proposal was put to a vote and was unanimously approved by the committee.

- C. Dr. Fahy presented on a course revision for CDS 5900 Advanced Clinical Practice and highlighted the following points.
 - a. Updates the content and course description to accurately describe the course.
 - b. Direct clinical teaching component provided for cohort students via bi-weekly video conferencing.

The proposal was put to a vote and was unanimously approved by the committee.

- D. Dr. Fahy presented on the catalog revision of CDS Master of Science Degree and highlighted the following points:
 - a. CDS 5091 be listed as a substitute for CDS 5090 to cohort students.
 - b. Revision to CDS 5900 to include the distance learning component for cohort students.
 - c. Online cohort program credit hour requirements will increase to 47-49 total.

The proposal was put to a vote and was unanimously approved by the committee.
