**AET 3053 Changed to AET 3253**

A new course proposal for AET 3053 was submitted to CAA last month. After discovering that this course number was previously used for another AET course, CAA advised that the number be changed. The School of Technology agreed to use AET 3253 for the new course.

**New Course Proposal – OPD 3000, Learning Analysis Through Portfolio Development**

Wyatt presented the proposal which aligns this portfolio course with others like it on campus. The hours for this course will count towards a student's graduation unlike the current OPD 1000.

This new course will include more theory and instruction. The proposal, with minor revisions, was placed on the agenda for voting at the next meeting.

**New Course Proposal – OPD 4865, Diversity in Organizations**

Hawkins presented the proposal. This course has been offered as a special topics course and is very popular with students. The proposal, with minor revisions, was placed on the agenda for voting at the next meeting.

**New Course Proposal – OPD 4700, Leadership in Organizations**

Hawkins presented the proposal. This course will serve undergraduates students and provide future graduate students with a better foundation for the graduate course in leadership. Lach stated that management faculty noticed a slight overlap with BUS 3010 that, although not significant enough to generate any problems, should be mentioned in the proposal. The proposal, with minor revisions, was placed on the agenda for voting at the next meeting.

**FCS 3800 and FCS 4685**

A motion was made and seconded to remove both of these proposals from the agenda. They are part of a larger group of proposals to be considered at another time and were mistakenly forwarded to the committee. Motion passed and items were removed.
