PROPOSAL FOR M.S. IN DIETETICS

Motion made and carried to take the proposal off the table. Kennedy-Hagan presented the proposal. The proposal was placed on the agenda for voting at the next meeting.

PROPOSAL FOR PROGRAM NAME CHANGE FOR M.S. IN FCS: DIETETIC OPTION

Motion made and carried to take the proposal off the table. Kennedy-Hagan presented the proposal. The proposal was placed on the agenda for voting at the next meeting.

<u>REVISED COURSE PROPOSAL – FCS 5153, NUTRITION IN THE LIFE CYCLE</u>

Motion made and carried to take the proposal off the table. Kennedy-Hagan presented the proposal. Student assessment data suggested the need for two semesters of Medical Nutrition Therapy. In order to create two semesters of Medical Nutrition Therapy, there is a need to

reduce FCS 5153 from three to two semester hours so that one hour can apply toward the new MNT course. The proposal was placed on the agenda for voting at the next meeting.

<u>NEW COURSE PROPOSAL – FCS 1275, FAMILY AND CONSUMER SCIENCES</u> PRACTICUM

Meadows presented the proposal. FCS 1275 would provide a shadowing experience that would help students solidify what they thought or explore what they liked about a particular FCS field of study. They would be able to do this on a freshman level prior to the required capstone FCS internship. The proposal was placed on the agenda for voting at the next meeting.

NEW COURSE PROPOSAL – FCS 2275, INTERNSHIP FOR NON-MAJORS

Meadows presented the proposal. This course provides an introductory experience and a way for non-FCS majors to receive credit for an FCS internship experience since FCS 4275 is just open to FCS majors. The proposal was placed on the agenda for voting at the next meeting.

PROPOSAL FOR ENTREPRENEURSHIP MINOR

Snyder suggested that the agenda item be tabled so that the program committee could reconvene to address recent developments. Flight made the motion to table the agenda item but the motion was not seconded. The proposal was then opened for discussion. Prior to the meeting, the School of Business had forwarded a position paper to Chairperson Drage requesting ownership of the minor and listing concerns with the minor along with possible solutions. Guests and members representing all three schools within the college expressed opinions about the position paper and whether or not it should be considered at this meeting since it was not part of the agenda. Dean Hoadley stated that open discussion of all materials would be in the best interest of everyone involved.

Nantz stated that the business curriculum committee is in favor of the minor but has process and governance issues. She expressed that the business curriculum committee needed to look at the course proposals within the minor as well as the sequencing of the ENT courses and suggested that the other schools do the same.

After much discussion, Dean Hoadley noted that all three schools within the college seemed to be in favor of the idea of an entrepreneurship minor but that there are process and content issues that need to be resolved and questions that need to be answered before the minor can move forward. She asked the ENT program committee to expand scope. She would like to meet with the ENT program committee and all other members of the departmental curriculum committees. The ENT program committee agreed to meet. The proposals for the minor and the ENT courses were left on the agenda for the next meeting.
