**NEW COURSE PROPOSAL- FCS 5150, MEDICAL NUTRITION THERAPY-FALL**

Kennedy-Hagan presented the proposal. The proposal was put on the agenda for voting at the next meeting.

**REVISED COURSE PROPOSAL – FCS 5154, MEDICAL NUTRITION THERAPY-  
SPRING**

Kennedy-Hagan presented the proposal. The proposal was put on the agenda for voting at the next meeting.

**VOTING ON PROPOSAL FOR REVISION OF BSB BUSINESS ADMINISTRATION DEGREE PROGRAM**

The proposal was approved.

**VOTING ON REVISED COURSE PROPOSAL – FCS 3233, MERCHANDISING PLANNING & CONTROL**

Dilworth again presented the proposal with changes suggested at last meeting. Noll questioned overlap with MAR 3875 and suggested that the outline and objectives focus more on textile, apparel, and fashion. Flight also suggested that the proposal needs to emphasize apparel and textile. The committee recommended that the title be changed to Apparel and Textile Merchandising. Noll and Roszkowski would like the School of Business faculty to review the proposal once changes have been made by Dilworth. Vote was taken and proposal approved pending changes and School of Business committee review.

**VOTING ON NEW COURSE PROPOSAL – FCS 3740 – PROFESSIONAL HOSPITALITY MEETING MANAGEMENT**

Sowa requested that changes be made to the proposal in areas that addressed the communication courses. Drage suggested changes in the grading chart. Proposal was approved as revised.

**VOTING ON PROPOSAL TO REVISE THE FAMILY AND CONSUMER SCIENCES: APPAREL & TEXTILES, CONSUMER STUDIES, HOSPITALITY, AND MERCHANDISING OPTION CONCENTRATIONS**

Proposal was approved with correction of FCS 3233 title.

**VOTING ON PROPOSAL TO REVISE THE CAREER AND ORGANIZATIONAL STUDIES PROGRAM**

The proposal was approved.

**VOTING ON PROPOSAL TO CHANGE PROGRAM NAME AND PREFIX FOR COS PROGRAM**

**NEW COURSE PROPOSAL – INT 1323, COMPUTERS FOR APPLIED ENGINEERING AND TECHNOLOGY**

McDonald presented the proposal. The proposal was put on the agenda for voting at the next meeting.

**NEW COURSE PROPOSAL – INT 3414, SELECTION AND MANAGEMENT OF TECHNICAL PROJECTS**

McDonald presented the proposal. Noll expressed concern with the amount of overlap with MGT 4850, Project Management. Management faculty members have not had a chance to look at the proposal. Noll requested that they look at it prior to the committee voting on the proposal. The proposal was put on the agenda for voting at the next meeting. This should allow ample time for the management faculty to review the proposal.

### **PROPOSAL FOR REVISION OF INDUSTRIAL TECHNOLOGY PROGRAM**

McDonald presented the proposal. Nantz advised that the English and Health Studies faculty be made aware that their courses will no longer be required of INT majors. Noll expressed concerns with students being given the choice of taking either INT 1323 or BUS 1950 since this may cause confusion with articulation of community college courses. McDonald agreed to take BUS 1950 out of the program. The General Concentration was thought to be confusing and McDonald agreed to reword the concentration requirements. Other minor changes were made to the proposal and it was put on the agenda for voting at the next meeting.

### **PROPOSAL TO CHANGE PROGRAM TITLE AND PREFIX FOR INDUSTRIAL TECHNOLOGY**

McDonald presented the proposal. Confusion over whether or not there was a degree title changed resulted in the proposal being tabled until the next meeting. Hennig will speak to Mary Herrington-Perry about the rules surrounding the degree title.
