### **CTE Program Change**

Chadd presented the proposal that would require students in the program under the Fall 2010 or later catalogs to earn a C or higher in all required courses. Effective in 2012, the State will require all education majors to earn a C or higher in all required courses. As a result of this impending change, the CTE Program Committee has decided to make this change effective with the Fall 2010 catalog. Motion was made and vote taken and approved to set aside the rules and vote on this proposal. Vote was taken to approve the proposal. Proposal approved.
