MINUTES

The minutes of the March 9, 2009 meeting were approved as published.

WRITING ACROSS THE CURRICULUM

Taylor presented this proposal that will be discussed at CAA next year. Questions were raised as to how this requirement would be benchmarked and posted in DARS and Banner. Individual units from the college will discuss the proposal and provide feedback to Taylor by mid October, 2009.

<u>VOTING ON NEW COURSE PROPOSAL- FCS 5150, MEDICAL NUTRITION</u> THERAPY-FALL

Vote taken. Proposal approved.

<u>VOTING ON REVISED COURSE PROPOSAL – FCS 5154, MEDICAL NUTRITION THERAPY-SPRING</u>

Vote taken. Proposal approved.

<u>VOTING ON NEW COURSE PROPOSAL – INT 1323, COMPUTERS FOR APPLIED ENGINEERING AND TECHNOLOGY</u>

Nantz suggested minor changes to the proposal. Noll and Roszkowski expressed concern about waivers being approved to substitute BUS 1950 for INT 1323 for transfer students. After much discussion, it was agreed that BUS 1950 alone would never be directly substituted for INT 1323. However, as deemed appropriate on a case by case basis for transfer students, BUS 1950 plus additional coursework and/or experiential learning in this area may be substituted for INT 1323. Vote taken on proposal. Approved.

<u>VOTING ON NEW COURSE PROPOSAL – INT 3414, SELECTION AND MANAGEMENT OF TECHNICAL PROJECTS</u>

Nantz provided the committee with a memo from Denise Smith on behalf of the Management Discipline which requested that the proposal not be approved. Reasons for disapproval were listed on the memo and were presented by Nantz. McDonald defended the proposal to the committee. Nantz suggested tabling the proposal. A motion was made and approved to table the proposal until next Fall to provide time for more discussion between the two areas of Industrial Technology and Business.

VOTING ON PROPOSAL FOR REVISION OF INDUSTRIAL TECHNOLOGY PROGRAM

McDonald informed the committee that he would pull INT 3414 from the proposed program revision so that the new program could still be effective Fall 2009. Nantz suggested that McDonald include a table at the beginning of the catalog copy that would summarize program requirements. McDonald agreed. Vote taken. Proposal approved.

PROPOSAL TO CHANGE PROGRAM TITLE AND PREFIX FOR INDUSTRIAL TECHNOLOGY

Hennig reported that a change in degree title was not necessary since the degree is still a B.S. Only program title and prefix need to be changed. The rules were suspended and a vote taken to approve this proposal. Proposal approved.

PROPOSAL TO CHANGE FCS MERCHANDISING CONCENTRATION UNDER FCS: ACHM OPTION

Wilkinson presented the proposal which only involved adding STA 3970 as an elective for the Merchandising Concentration. The proposal was placed on the agenda for voting at the next meeting.

REVISED COURSE PROPOSALS – FCS 3810, CHILD CARE ISSUES; FCS 4240, CHILD ADVOCACY; FCS 4246, CURRICULUM FOR CHILD CARE HOMES/CENTERS; FCS 4680, FAMILY SYSTEMS AND THEIR IMPACT ON CHILD CARE;

Coonce presented the proposals which only involved adding technology-delivered sections to each of the courses. The rules were suspended and the committee voted to approve the proposals so that they could be effective Fall 2009.

<u>REVISED COURSE PROPOSALS – MGT 3330, LEGAL ASPECTS OF</u> ENTREPRENEURSHIP; MGT 3320, ENTREPRENEURSHIP AND SMALL BUSINESS

Roszkowski presented the proposals. Word of a possible Entrepreneurship Minor is circulating and inquiries have been made asking for these courses. They are now at the 4000 level (MGT 4330 and 4320) but are really entry-level courses in entrepreneurship. In order to facilitate offering these courses to students outside the business major, the courses have been renumbered to the 3000 level and prerequisites have been adjusted accordingly. Both proposals were placed on the agenda for voting at the next meeting.

REPEATING UNDERGRADUATE PROFESSIONAL EDUCATION COURSES WITH FIELD EXPERIENCES AND PRACTICA

The committee discussed the limit being put on the repeating of these courses and was in agreement. In our college, only CTE majors would be affected. Nantz will provide feedback to Dean Jackman.
