<sup>•</sup>Group Activity: Each week students will individually (outside of class) review several case studies, list the symptoms, and make a diagnosis and possible treatment options. In class small group work will involve the case consultation format to determine the diagnosis. (Complete or Incomplete)

<sup>•</sup>Research Paper: Students will submit an 8-10 page paper presenting the results of an exploration into the treatment of a specific disorder within the general categories.

- •Case Summary/Assessment: Students will develop a written case summary/assessment, a diagnosis, and a treatment plan of one of their current clients. Students will provide an introductory paragraph about their work with the selected client, number of sessions, and their impressions of progress. Students will be asked to make a short report of this project to the class
- •Cultural Paper: Students will submit a five-page paper (references and cover page not included) presenting a specific diagnosis including information about how culture might affect their diagnostic decision.
- •Learning Assessment 1 and 2: Students will be given an exam over selected material using multiple choice and short answer.

\*In writing-active courses, frequent, brief writing activities and assignments are required. Such activities -- some of which are to be graded – might include five-minute in-class writing assignments, journal keeping, lab reports, essay examinations, short papers, longer papers, or a variety of other writing-to-learn activities of the instructor's invention. Writing assignments and activities in writing-active courses are designed primarily to assist students in mastering course content, secondarily to strengthen students' writing skills. In writing-intensive courses, several writing assignments and writing activities are required. These assignments and activities, which are to be spread over the course of the semester, serve the dual purpose of strengthening writing skills and deepening understanding of course content. At least one writing assignment is to be revised by the student after it has been read and commented on by the instructor. In writing-intensive courses, students' writing should constitute no less than 35% of the final course grade. In writing-centered courses (English 1001G, English 1002G, and their honors equivalents), students learn the principles and the process of writing in all of its stages, from inception to completion. The quality of students' writing is the principal determinant of the course grade. The minimum writing requirement is 20 pages (5,000 words).
