

## **Proposed Revision to the Communication Disorders & Sciences**

### **Master of Science Degree**

#### **Requested Changes:**

- CDS 5220 Language and Literacy new graduate course (previously at undergraduate level)
- CDS 5200 Developmental Syndrome Disorders eliminated course
- CDS 5250 Advanced Study in Language Disorders eliminates narratives from content and adds executive function and Autism to content
- CDS 5170 Voice Production and Disorders new graduate course (previously at undergraduate level)
- CDS 5150 Stuttering changed from a 3 to 2 hour course
- CDS 5400 Special Topics- Must repeat 1 time for non-thesis option (reduced from 2)
- CDS 5800 Grand Rounds in Communication Disorders changed from a 3 to 2 hour course.

#### **Rationale for Changes in Master of Science in Communication Disorders and Science**

Changes in the graduate Communication Disorders and Sciences program are proposed to update the curriculum and better align EIU's CDS program with other universities across the state. The CDS 5220 course is proposed as a new 3 hour graduate level course to include content from the eliminated undergraduate language and literacy course, as well as the new ISBE requirements for reading methods and reading in the content area. CDS 5250 Advanced Study in Language Disorders has been revised to include content from the eliminated CDS 5200 (Syndromes) course. CDS 5170 Voice Production and Disorders is taught at most universities at the graduate level. CDS 5150 Stuttering, a specialized disorder area and CDS 5800, Grand Rounds in Communication Disorders were reduced from 3 hour courses to 2 hours to accommodate the additional disorder courses added at the graduate level. Special topics (CDS 5400) were also reduced from a required 3 sections to 2 to accommodate new courses and to be consistent with thesis options.

### Graduate Degree Programs

**Program Mission:** With an undergraduate major in communication disorders and sciences, this program meets the requirements for the Certificate of Clinical Competence awarded by the American Speech-Language-Hearing Association, and the Speech-Language Pathologist License awarded by the Illinois Department of Professional Regulation, and a K-12 educator license (with endorsement awarded by the Illinois State Board of Education). Students may opt out of the educator license concentration in special circumstances with permission of the graduate coordinator.

**Accreditation:** Council on Academic Accreditation of the American Speech-Language-Hearing Association in the area of speech-language pathology.

**Admission Requirements:** To be eligible for degree candidacy, applicants must meet all of the requirements for admission to the Graduate School (see "[Admission to Graduate Degree and Certificate Programs](#)"). Applicants must provide a documented score of the General Test of the Graduate Record Exam. In addition, students must have at least a 3.00 grade point average (A=4.0) in the undergraduate communication disorders and sciences major for admission consideration to the graduate program at Eastern Illinois University. Admission is competitive and meeting minimum GPA requirements does not guarantee admission. Admission is determined by a graduate faculty committee. The committee considers all applications, including transfers from other four-year colleges and universities. With department chair consultation and approval, students may enroll for some courses on a non-degree basis. Students who have a baccalaureate degree in a major other than CDS must complete all 2000 level CDS courses and CDS 3100, 3200, 3500 and 3700 or their equivalents prior to being considered for admission to the CDS graduate program. To be admitted to the program for the Master of Science in Communication Disorders & Sciences with Educator License, students must obtain a passing score on the Test of Academic Proficiency. For the online cohort program, students must demonstrate relevant work experience with children and/or adults; secure a partnership with a school setting for practicum; and meet all other admission criteria.

**Degree Audit:** The graduate plan of study is the EIU Degree Audit, which is generated automatically in the Degree Audit Reporting System (DARS) at the time of degree or certificate candidacy. Modifications of the standard EIU Degree Audit are submitted by the graduate coordinator to the certification officer in the Graduate School at the time modifications are approved. The Degree Audit serves as an unofficial summary of requirements for the program. Degree and certificate candidates are advised to review the comprehensive summary of the Degree Audit process specified on the "Requirements for All Degree and Certificate Candidates" section of the *Graduate Catalog*.
