





PROFESSIONAL EXPERIENCE

Director of University Housing and Dining Services – Eastern Illinois University July 2001 – Present

Responsible for the administration of all dimensions of the University Housing and Dining program. This includes residence life, dining, facilities, camps and conferences and business operations. Responsible for an annual budget of 39 million dollars, 200 full time civil service and professional staff and 900 student employees. The housing system has a capacity of 5000 students in twelve residence halls, nine Greek houses hosting 19 Greek affiliated chapters and 300 apartments.

Associate Director of Residence Services – University of North Dakota 1998 – 2001

Responsible for supervision of central housing office operation, including the overall residence hall and central office functions, staff supervision, and development and administration of 4.5 million dollar budget. Provide vision and direction for all residence life functions. Supervise marketing efforts for Dining Services and the Operations Division. Supervise operational functions of the University Children's Center, which provides care for 75 children, in cooperation with the College of Education. Developed tools to assist center director in daily management of the operation's \$275,000 budget. Oversee residence hall service center and camp and conference operations. Advise the Association of Residence Halls Policy Board and the National Residence Hall Honorary.

Director of Residence Halls – University of North Dakota 1990 – 1998

Responsible for the overall management of residence life functions. Coordinated central housing office operation, including staff supervision and administration of residence hall and central office budget of 4.5 million dollars. Supervision of Associate and Assistant Director and indirect supervision of central office staff who manage contracting, room assignments and billing. Acquired additional responsibility for supervision of marketing efforts for Dining Services and the Operations Division in 1994.

Interim Director Chester Fritz Auditorium – University of North Dakota 1989 – 1990

One-year split (80% auditorium and 40% housing) appointment to manage 2400- seat performing arts facility during time of staff transition. Responsible for implementing staff selection and training practices and stronger fund accountability. Operation moved from a \$100,000 deficit to an \$85,000 surplus.

Associate Director of Housing – University of North Dakota 1987 – 1990

Responsible for the supervision of all complex directors, residence hall directors and resident assistants in facilities housing 3100 students. Assumed direct reporting line to the Director of Residence Services and responsibility for the camp and conference operation.

Assistant Director of Housing – University of North Dakota
1984 – 1987

Responsible for the supervision of 4 complex directors, 13 residence hall directors and 85 resident assistants in facilities housing 3100 students. Served on central office staff team to create and implement residence life program.

Complex Director – University of North Dakota

Responsible for the overall operation of a 4-residence hall complex housing 1000 students. Supervised 4 residence hall directors and 23 resident assistants, service center staff and 1 part time secretary.

Responsible for the overall operation of a co-educational residence hall of 150 with shared responsibility for a complex of residence halls serving 450 residence hall students.
