Proposed Type of Degree, Curriculum Options, and Program Mission

- Master of Arts (M.A.) was changed to Master of Science (M.S.) to more accurately represent the types of courses in the curriculum. When the M.A. in Gerontology (former name of Aging Studies) was created in the 1980s, M.A. best represented the types of courses in the curriculum. Since the early 2000s, the curriculum has largely evolved into an M.S. degree program with the majority of required and elective courses and content in the areas of Family Science (HSL), Kinesiology (KSR), Psychology (PSY), Public Health (PUBH), and Biology (BIO). Dr. O'Rourke conferred with the Graduate School Dean, who consulted with the Provost. The Dean and Provost are supportive of a transition from M.A. to M.S. for the Aging Studies program and the Dean and Provost confirmed that, beyond curriculum committee approvals, there are no additional approvals required to transition from an M.A. to an M.S. graduate degree program.
- An additional curriculum option, the M.S. in Aging Studies: Long Term Care Administration was added. For the past 18 months, the Aging Studies Board (comprised of faculty and administrators representing each academic unit in the interdisciplinary degree program) has engaged in surveying existing graduate programs in Long Term Care Administration and discussing the need for change in the M.A. in Aging Studies program, largely due to decreased enrollment. Very few long term care administration degrees exist in the United States. Yet, the aging population growth is fueling greater demand for long term care residential and community programs. As for enrollment after consecutive years of increased enrollment, recent academic semesters since January 2020 have yielded small but consistent and concerning declines in enrollment. The Aging Studies Board concluded that the current best plan of action is to:
 - o retain the current M.A. (proposed M.S.) in Aging Studies degree option for students who are interested in beginning or continuing in a more generalized or, initially, in a non-program administrative aging career track;
 - o add the M.S. in Aging Studies: Long Term Care Administration option with a well-defined, specialized curriculum to (1) align with and meet all core competencies required to apply for the Nursing Home Administrator Exam and (2) prepare students to begin or continue in administrative careers in nursing homes or assisted living, supportive living, and independent living residential care and community programs;

and

- o within the well-defined and specialized M.S. in Aging Studies: Long Term Care Administration curriculum, offer the maximum amount of course choice and flexibility for students while still aligning with core competencies required to apply for the Nursing Home Administrator Exam.
- Editorial changes were made to the wording to more clearly and concisely articulate the program mission and description.

Degree Requirements

- Change M.A. to M.S., as described above.
- Add option for M.S. in Aging Studies: Long Term Care Administration, as described above.
- For M.A. (proposed M.S.) in Aging Studies, move HSL 4846: Aging and the Family from an elective to a required course to better recognize and include the importance of families/support care persons in the aging process.
- For M.A. (proposed M.S.) in Aging Studies, move Thesis, Independent Study, and Internship from required to elective, as a substantial percentage of Aging Studies students have prior or current aging-specific career experience and/or are not pursuing postmaster's higher education degrees (Ph.D. or Ed.D.) or career-related research paths.
- For M.A. (proposed M.S.) in Aging Studies, revise the following for elective courses:
 - Add two Biological Sciences courses (BIO 4834 and BIO 4835) for additional student choices, especially for those students who may pursue the accelerated program and/or for those students who are interested in careers focused on biological diseases of aging (e.g., dementia); and
 - O Delete REC 4950: Leisure and Aging, as KSR 5225 Physical Activity and Aging is a required course that is more aligned with students' career choices and no students have elected to take REC 4950 in the past 7 years and since the program became an online degree.
