# Rationale:

- The Middle Grades option has had low enrollment with the change in the ISBE regulations. We do wish to keep the classes in the catalog, but not offer the Middle level discipline because low enrollment does not allow for the classes to be offered.
- All disciplines for the C & I Master's program will be a consistent 18 semester hours.
- ELE 48553 should have originally been in the program. There was an error in the original class number.
- EDF 5320 Foundations of Cross Cultural Education was a class designed for this emphasis and by including this class students will have the broad range of classes related to ESL students.
- The students choose an elective only if they have had ELE 4890 in their undergraduate program. Therefore, the electives need to be listed as electives only.
- In the Reading Instruction option, the addition of the classes in the option allows those completing the option to take the Reading Teacher test for state endorsement, having done all of the required classwork. Previously we have had students complete the option and not able to take the reading teacher endorsement test because they were missing a children's literature class.
- We do wish to drop the Middle Grades option. There has been minimal enrollment in this option in the past three years. The Illinois State Board of Education has changed rules. Candidates can have 18 hours in a content field, take a methods class and test for Middle Level endorsement.

# Action Item Requested:

Removal of the Certification of Comprehensive Knowledge requirement as a graduation requirement for MSED C&I

#### Rationale:

The MSED C&I program has two capstone course options (EDU 5900 Applied Research and EDU 5950 Thesis). Formal documentation of achievement is not needed beyond successful completion of either course option. Procedures for Certification of Comprehensive Knowledge are not required.

## '21/'22 Graduate Catalog Graduation Statement:

# Comprehensive Knowledge and Examinations for Graduate Degree Candidates

Degree candidates are expected to achieve comprehensive knowledge in the area in which the degree is to be offered. Many programs require formal documentation of this achievement through the Certificate of Comprehensive Knowledge and/or completion of comprehensive examinations. Candidates should consult with graduate coordinators regarding the requirements for the certificate if it is part of the graduate degree program. Programs establish procedures that are used to examine the candidate's comprehensive knowledge. Procedures may include written examinations, oral examinations, national or state examinations, or other assessments of knowledge. Upon the candidate's successful completion of the required procedures, the coordinator of graduate study will document achievement of the Certificate of Comprehensive Knowledge. Some programs also record completion of comprehensive examinations on the graduate transcript. Programs may designate completion of the examination as "pass" or "pass with distinction."
