Fall 2014 Commencement Marshal Nomination

The Commencement Marshal carries the mace and leads the processional during commencement ceremonies. Annually, I receive many outstanding nominations and this year was no exception. Upon the nomination from Dr. Britto Nathan, Graduate Coordinator of the Master of Science in Biological Sciences, I have selected Dr. Robert Colombo, Professor of Biological Sciences and Graduate Faculty member of the Master of Science in Biological Sciences, to serve as the Graduate School Commencement Marshal for the December 2014 Commencement Ceremonies. Dr. Colombo is characteristic of the criteria for Commencement Marshal as outlined below:

- Record of Graduate Teaching: Professor Colombo has an extensive history of graduate level teaching including courses in Ichthyology (BIO 4950), Population Ecology (Bio 5208), Graduate Seminar (BIO 5150), Fish and Wildlife Techniques Bio 5372). Dr. Colombo has mentored 3 Distinguished Graduate Students and Hamand Scholars (Anthony Porreca, Cassie Moody, and Vaskar Nepal). His students have been the recipients of state and national awards including the Lewis L. Osborne Award at the Illinois American Fisheries Society, the North American Sturgeon and Paddlefish Society Travel Award, and the Equal Opportunity Section of American Fisheries Society Award.
- Record of Graduate Research: Dr. Colombo has an exemplary record of graduate research. He
 is the recipient of numerous grants during this tenure at Eastern. He has published numerous
 manuscripts with his students as co-authors, and has earned the Rodney S. Ranes Outstanding
 Graduate Faculty Mentor Award and the College of Science Student Advisory Board Outstanding
 Faculty Award.
- Record of Graduate Leadership. Dr. Colombo serves on the Biological Sciences Graduate
 Committee and was selected to speak as the Illinois Association of Graduate Schools Annual
 Meeting to discuss exemplary faculty mentoring. He was instrumental with helping to advance
 several new interdisciplinary degree programs and has participated in numerous graduate
 program activities.

Dr. Colombo's record as a teacher-scholar exemplifies the ideal established by the Council on Graduate Studies for recognition as Commencement Marshal from the Graduate School and I believe this will be a fitting tribute to his record of achievement.
