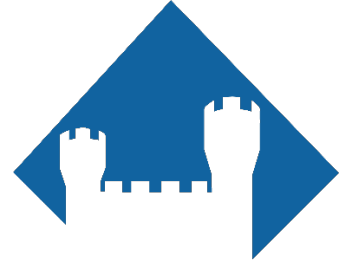

RATIONALE: Family & Consumer Sciences was realigned Fall 2018 and is no longer a stand-alone program. The FCS Family Services option is proposed to be Human Services Program Administration, and corresponding courses and major requirements have been revised to align with the focus of the new department and revised degree.

As the program focuses exclusively on human services, the program is preparing students for entry into the profession or for graduate school (e.g., social work, clinical counseling, and community leadership). In order to make students competitive, they need to be able to manage the demands of challenging classes, making foundational information important.
