- d. Under Prerequisites change permission of instructor to permission of DPD coordinator

### RATIONALE

This language will better clarify the NTR and FCS course equivalencies for students and advisors when viewing the catalog as the FCS 4750 in the title doesn't transfer into the Catalog View in PAWS. The grade requirement of C or better in NTR/FCS 3755 is intended to promote a higher level of achievement in the academic program. Changing the permission granting from the instructor to the undergraduate DPD Coordinator is more in line with current practice.
