Rationale:

The Curriculum & Instruction graduate program was originally a graduate program shared and supported by two departments. Those two departments have since merged. As a result, the prefixes for the graduate program courses offered by the department have a variety of different prefixes that represent the old departments. Further, some of the prefixes represent the former Elementary Education department with the prefix ELE. This has created problems for some of the students enrolled in the Curriculum & Instruction master's program. Students in the program are teachers of all grade levels. Therefore, when a secondary teacher enrolls in a course with an ELE prefix their districts refuse to recognize it as appropriate graduate credit.

The prerequisite additions are requested because students were taking the research courses out of sequence. Research 2 builds on Research 1 and students taking them out of sequence had a harder time with the material. The committee anticipated that there may be rare cases where it was impossible or impractical for a student to take the courses in sequence. That's why the grad coordinator or chair can waive the requirement. The committee felt the decision should not be left to the advisor.
