VI. COMMUNICATION AND INFORMATION:

A. ISBE UPDATES:

Legislative Updates:

- 1. The Governor's Disaster Proclamation is extended to December 2023, the EDTPA is anticipated to resume for Fall 2023 along with licensure content exams being required to be passed before student teaching. It is anticipated, in June 2023, EdTPA requirements to return SP'24 with passing exam before student teaching.
- 2. As of January 1, 2023, candidates can serve as substitutes with zero credit hours and no licensure.
- 3. IPTS standards- no updates

> Initiatives Updates:

1. Samantha Phillips has been hired to continue work on "Culturally Responsive Initiative" from the Dean's suite by acting as a liaison for faculty. She will work on

- strategies, format, assist with resources, etc. and serve on the committee. She will also assist with the scheduling of speakers.
- 2. COTE will oversee "diversity" per Dean Henderson. The committee will work on racial and ethnic teacher education where students will complete programs, recruitment, retention, committee needs to set goal for increasing student population by at least 10%. Committee will need to look at diversity numbers in different areas, looking at exit interviews for answers and areas to work on, mental health needs, monetary resources, testing support, MTIEP and MTEA programs.
- 3. CAEP- more schools are doing their own accreditation, areas of concern with CAEP include cost (\$5,000.00 yearly, visit not included), not necessary to prepare teachers. At the February 10 meeting, will include a break out of groups to work on initial matrix draft (informational item) to locate where concepts and holes are. Initial draft should be completed by April 1.
- 4. MAT- a hearing will be conducted in April, Christy will send names interested in program courses offered thru ought the summer.
- 5. Committee- will take 2 weeks to gather information, all information will be placed on a google drive folder. Melissa Ames will collect all information.
