V. Selection of 2023-2024 COTE Curriculum Committee Vice Chair:

VI. Teacher Ed Update & Executive Director's Report:

- A. Governor's Disaster Proclamation- the proclamation has ended and reverts to candidates must past content tests prior to student teaching placement. The Spring 2024 candidates have been notified and given December 8, 2023 as a due date to have all tests/paperwork completed and submitted to the COE Deans' Office. Registration in student teaching courses will take place the first week of classes in January, 2024.
- B. EdTPA- On August 4, 2023, the Governor signed the bill, EdTPA requirement is on hold. It is possible that a task force to regulate state-wide required assessment may be created. If this occurs, the hope is for EIU to continue using its current student teaching assessments. At this time, it is unknown how an EIU representative can be appointed to the task force.
- C. CAEP- a proposal for voluntary removal from CAEP has been written. Dr. Christy Hooser has met with stake-holders and k-12 partners. There will not be a "suspension of the rules" to push this through the committee. Dr. Christy Hooser has asked each member to review thoughtfully, as a quorum will be needed for voting purposes.
