MINUTES OF THE COLLEGE OF EDUCATION CURRICULUM COMMITTEE -- 02/22/2021

The College of Education Curriculum Committee met at 2:00 p.m. on Monday, February 22, 2021, via Zoom.

Jim Howley called the meeting to order.

<u>Minutes</u>

Jon Coleman moved to approve the January 25, 2021 minutes. Aaron Mattox seconded the motion. The minutes were approved unanimously with no changes.

TLF: Program Modification - Replace PUBH 3000 with PUBH 3200:

Modification of EC, ELE, and MLE programs to replace required course PUBH 3000 with PUBH 3200.

Rationale for the request:

PUBH 3000 is no longer available and has been substituted with PUBH 3200. The EIU department of Health Studies made this modification to their course offerings.

Jon Coleman motioned to approve the proposal and Aaron Mattox seconded the motion. The proposal was approved unanimously with no changes; Effective date – Fall 2021

TLF: Program Modification - MLE Course Removal:

Modification of Family and Consumer Sciences Professional Education program to accommodate the removal of some MLE courses.

Rationale for the request:

It has been brought to our attention that with the change in state requirements, not all the MLE courses listed in the catalog under Family and Consumer Science Education will need to be included as currently listed in the Secondary Education program. This modification would bring the requirements parallel with those in Business Education and Technology Education. We will be asking that the following courses be removed from the CTE- Family Consumer Sciences Education program (the courses will still be available for student to take, but not required of the program) listing in the catalog under the heading of Secondary Education Program - Total 42 hours (with the proposed change):

MLE 3100 – Curriculum and Instruction in Liddle-Level School. Credits: 3 MLE 3150 – Interdisciplinary Teaching in the Middle-Level School. Credits: 3 MLE 40001 – Practicum in Middle School Curriculum & Instruction. Credits: 1

Jon Coleman motioned to approve the proposal and Aaron Mattox seconded the motion. The proposal was approved unanimously with no changes; Effective date – Fall 2021

TLF: Master Teacher Program Removal from Catalog and IBHE Listing:

Removal of the M.S. Ed. Master Teacher program from any catalog entries and from IBHE listing as an approved program.

Rationale for the request:

The MS. Ed. Master Teacher has been removed from the graduate catalog and is not supported in any fashion by the university. The program was "officially" suspended in 2013, but not removed from the IBHE program listing. There are no students pursuing this degree.

Jon Coleman motioned to approve the proposal and Aaron Mattox seconded the motion. The proposal was approved unanimously with no changes; Effective date – Fall 2021
