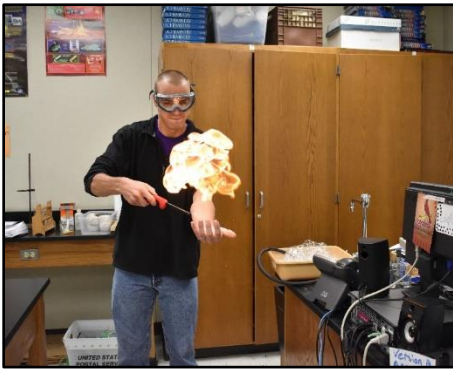

Program Description

The EIU Accelerated Post-Baccalaureate Teacher Licensure Program will be offered for the first time in 2020-21. Candidates who have completed a bachelor's degree program in a designated content area and have passed the appropriate state content area test are eligible for admission to the program. Content areas that will be offered in the program are:

- Career and Technical Education (Business, Family and Consumer Sciences, or Technology Education)
- English
- History-Social Science
- Foreign Language (French, German, or Spanish)
- Mathematics
- Science (Biology, Chemistry, Earth Science, or Physics)



Candidates will take four courses in Summer 2020 (June 1-July 24) on the EIU campus in Charleston, with some of the coursework delivered in an online or hybrid format. During the Fall 2020 and Spring 2021 semesters, candidates will complete a full-year, full-time residency in a secondary school and complete one online class each semester. During the Spring 2021 semester, candidates will complete the edTPA Portfolio Assessment required for licensure by the State of Illinois. (Note: Career and Technical Education candidates will need three additional online classes in Middle Level Education for their endorsement.)

Course Sequence (30 semester hours)

June/July 2020 (12 semester hours): EDP 2330; EDF 2555G; SED 3330; SPE 4500.

Fall 2020 (9 semester hours): Departmental methods course; first semester of residency.

Spring 2020 (9 semester hours): SED 4330; second semester of residency.

Admission Requirements (must be documented by May 15, 2020 unless otherwise noted)

- Letter of Application and Resume to the Dean, College of Education (March 15, 2020).
- Acceptance by the EIU Graduate School as a non-degree seeking student.
- Bachelor's degree in the designated content area with a minimum 2.65 GPA.
- Passing score on the appropriate state content area test (see www.il.nesinc.com/).
- Fingerprinted-based Criminal History Check.

Residency Placement Requirements (must be documented by July 24, 2020)

- Completion of Summer 2020 coursework with a minimum 3.00 GPA and no D's or F's.
- Speech and Hearing Clearance.
- State-required physical examination and tuberculosis check.
- Completion of Mandated Reporter training.
