Please note that a GPA of 2.75, both cumulative and in the major, is required for departmental approval to student teach. Major GPA based on all English courses taken at EIU except English 0990, 0995, 1000, 1001G, 1002G, 1091G, 1092G, and General Education courses other than 3009G and 3099G. A grade of C or better is required in each course that applies to the major.
