- 2. A Basic Skills workshop will be held on April 2. This will be limited to 90 students and is for those students who have already reviewed the test framework and have already taken the diagnostic test.
- 3. Dr. Heidi Larson will present a series of relaxation workshops to begin after Spring Break. More information on this should be available later this week.
- 4. Results from the February 12 test date will be available on Friday.
