V. <u>Teacher Education Update and Executive Director's Report</u>

- 1. Dr. Bower reported that over this past summer, a review was done of teacher education graduates over the last 5 years to see where they are teaching. The information collected is as of the 2015-2016 school year since 2016-2017 data is not yet available. He will share the results once the data has been compiled.
- 2. Dr. Bower reported that Career Services is reaching out to provide greater services to our students in teacher education. Students are encouraged to sign up for the PANTHER TraCS program offered by Career Services.
- On September 27, Dr. Bower will present ED 104 to update community college coordinators on recent changes in teacher education. This is being held in conjunction with the EIU Community College Articulation Conference on September 28.
- **4.** CAEP Accreditation visit is scheduled for November 2017. We are reviewing data to determine what needs to be done for this. More information will be coming.
- 5. The TASC Center is open and ready for business. Here is a link to the website for information on services and hours, <u>http://www.eiu.edu/basicskillstest/</u>.
- **6.** In April, Illinois high schools will begin offering the SAT to juniors instead of the ACT. Acceptable SAT scores can be used in lieu of TAP for selection to teacher education.

- 7. Plagiarism has become a concern in regards to edTPA. No one from EIU has been identified as plagiarizing on the edTPA, but students from other schools have been caught. The ISBE is asking each school to develop a policy on how this will be handled in the event a student is caught plagiarizing. If you have any thoughts about this policy, please contact Dr. Bower. This will be on a future COTE agenda.
- 8. Dean Jackman expressed her thanks to Dr. Bower and Dr. Shank for organizing the CAEP process.
- 9. Everyone is encouraged to participate in the Vitalization Project that was announced during President Glassman's campus address last week.
