The Council on Teacher Education met at 2:00 p.m. on Tuesday, September 28, 2021

Dr. Ames called the meeting to order.

### **I. Minutes**

The minutes were unanimously approved from the September 14, 2021 meeting with no abstentions.

### **II. Communication and Information**

- A. Update Assessment Coordinator: Dr. Hooser shared an update from the CAEP visit. The advanced programs were accredited with 1 stipulation and 2 AFIs. The initial programs are working on uploading their rubrics to D2L which would eliminate LiveText. Dr. Hooser shared an update on the SPA report submission status from various programs.

- A. CPDH Request: Black Educational Advocacy Coalition- Dr. Collins Ayanlaja shared (via email) how these courses will monitor participation with its asynchronous format. The CPDH proposal passed unanimously with no abstentions (7-0-0).
- B. 21-13 – Computer Science for Teacher Licensure Minor Proposal-Dr. Marshall Lassak presented the proposal for a Computer Science Teacher Licensure Minor. Dr. Larson motioned to vote on the proposal and Dr. Laughlin-Schultz seconded the motion. The proposal passed unanimously with no abstentions (7-0-0).
- C. 21-14 – Mathematics for Teacher Licensure Minor Changes-Dr. Marshall Lassak presented the proposed changes for Mathematics for Teacher Licensure minor. Dr. Jones-Bromenshenkel motioned to vote on the proposal and Dr. Jones seconded the motion. The proposal passed unanimously with no abstentions (7-0-0).

### **V. Teacher Education Update & Executive Director's Report**

Dr. Lucas about the Diverse Educator Pipeline pilot and its impact on initial and advanced programs. Dr. Lucas and Ms. Samantha Phillips shared about the culturally responsive standards and the literature review being completed for the initiative. Dr. Lucas shared about discussion of a proposed MAT program in Secondary Education. The off-campus Elementary Education and Special Education cohorts in Champaign have 24 total students enrolled. The marketing for the Decatur program will begin soon and the proposed Danville cohort will be next. Dr. Lucas shared about the Early Childhood Education mandate and the consortium.
