I hope this communication finds you well and feeling great. I am writing to provide an update regarding how BEAC plans to approach this work and to solicit your thoughts. Regarding the new Section 24:50 Standards, we plan to offer a battery of eight two-hour courses (aligns with the 8 standards) that students can take as a prerecorded webinar or etc.

There will be opportunities to offer these workshops live using remote learning (e.g., Zoom) as well as offering in-person presentations. EIU can make this information available in a plethora of ways including to help meet ISBE's compliance of incorporating these standards into teacher preparatory programs and/or on-going continuing education credit. We will also document what students will be able to know and do for each standard.
