This is a request for records, which we respectfully request be provided on a timely basis based on the applicable statutory requirements. I have also filled out your forms request as required (see attached).

1. Pursuant to applicable authority, I am writing to request copies of the following "Documents" for the athletic department staff listed below:

- a. Current employment contract and salary for 13-14 academic year (Letter of intent, form agreement, or applicable document / record which shows annual compensation and start/end date of employment). If an employee does not have a formal written agreement, please provide (ideally in a spreadsheet or table format): Name, Compensation, and Start/End Date (or write "At Will" if applicable). I have attached an excel doc with each person's name I am requesting, so you can just enter their 13-14 salary if there is no formal written agreement.
- b. Most recent outside income form (ideally 12-13 fiscal year) for any employee if available (in cases where such a record exists per NCAA bylaw 11.2.2).
- c. Most recent income (ideally 12-13 fiscal year) associated with Sports Camps for any employee, if available.

2. Pursuant to applicable authority, I am writing to request a copy of any contract or written agreement in force (i.e., signed, fully executed) between the University's Department of Athletics (or its affiliates) and third parties regarding all of the following categories of subject matter:

- a. Apparel rights for athlete competition (through firms such as Nike, Adidas, Reebok, Under Armor, etc).
- b. Concessions for all athletic facilities (through firms such as Aramark, etc).
- c. Multi-media rights (through firms such as IMG, Learfield, Nelligan, etc).
- d. Pouring rights, sponsorship, ad and promotional rights (through firms such as Coke, Pepsi, etc).
- e. Ticketing management (through firms such as Paciolan / Ticketmaster, etc). Current Ticketing contract I have expired.
- f. Trademark licensing (through firms such as Collegiate Licensing Co.). The Trademark Licensing contract that was provided previously with CLC may have auto-renewed according to its terms; provided however, if new terms have been memorialized in a new contract document, then I request that new document (such as an amendment or new contract)

3. Pursuant to applicable authority, I am writing to request a copy of all season ticket and partial season ticket list prices (i.e., before discounting) advertised to the public for home men's basketball [DM1] games for each of the seasons from 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14. In addition, please include the priority points system or donor points system (namely, the method by which season ticket holders to home games of the men's basketball program are assigned their seat locations, and sometimes entitled to purchase season tickets for better seats to home games in those sports), as applicable in the foregoing seasons of each year requested.

If the requested records described above are available in electronic format (e.g., PDFs or CD), then I would prefer to receive the information in that format instead of paper copies. If you are able to email the records, I request all PDFs in a

single WinZip file in the responsive email (no password protected files, please). If you are unable to email the records or you require an address to process this request, please find below my mailing address.
