## Greek Week General Rules and Regulations

1. Practices/Try-Outs/Tugs/ may not begin until February 9<sup>th</sup> of the spring academic semester that Greek Week is held in.
  - a. If a chapter/pairing is found in violation, they will begin to lose sportsmanship points.
  - b. The number of points lost will be decided by the Greek Week Steering Committee
2. Participants must be **undergraduate** students at Eastern Illinois University from an Interfraternity Council, Panhellenic Council, National Pan-Hellenic chapter, or NALFO chapter.
  - a. Graduate students may not participate in events during EIU Greek Week.
3. A fully active and dues-paying member or new member of an Interfraternity Council, Panhellenic Council, National Pan-Hellenic chapter, or NALFO chapter.
4. Must be listed on chapters roster through the Office of Fraternity and Sorority Life.
5. The EIU Greek Week Steering Committee may make any rule changes as deemed necessary during events and in times of crisis.
6. The EIU Greek Week Steering Committee could make changes to the packet at any time and reload it to the EIU Greek Week website.
7. Complaints or issues concerning a Greek Week event, incident, chapter, or pairing must be submitted via the Greek Week Complaint Form
  - a. Complaints will only be taken via the Greek Week complaint form
    - i. No emails, social media posts/messages, or verbal complaints will be accepted.
    - ii. Complaints must be submitted no more than 12 hours after the Greek Week event, issue, or incident.
    - iii. Timeframe for complaints is as follows:
      1. February 9, 2026, to April 11, 2026.
  - b. Once a complaint is submitted, the Greek Week Overall Chairs, along with the Greek Week Overall Advisors, will meet to view the complaint.
    - i. They will then set up a meeting with the pairing in question to review their side.
    - ii. Once the meeting is concluded, the pairing in question will receive an email with the decided outcome decided upon by the Greek Week Overall Chairs and the Greek Week Overall Advisors.
    - iii. Depending on the complaint, the Greek Week Overalls and Greek Week Overall Advisors may seek additional evidence and discussion with the Greek Week Committee Chair and their Greek Week Committee Chair Advisors.
    - iv. Complaint decisions are final and may not be appealed.
  - c. Any fully active and undergraduate member (Initiated or New Member) may submit a Greek Week Complaint Form.

## Airband Information

### Rules and Regulations

1. Each pairing may include up to **18** people.
  - a. Each chapter within the pairing must provide a minimum of six to nine individuals.
  - b. The pairing allows members to select which additional spots to fill.
2. Time Limit: The Airband routine must be at least five (5) minutes and no more than seven (7) minutes.
3. No dances, props, or costumes may include any references to alcohol, controlled substances, racial insensitivity, etc.
4. Costumes can only be removed appropriately. Instruments and props are permitted but may not be thrown at any time (Absolutely no throwing objects into the crowd). Your chapter(s) must be incorporated in some way, shape, or form (i.e., prop, throw what you know, verbal/ appropriate chant). All costume and prop changes and transitions must be submitted in writing no later than **April 3, 2026**. All props and costumes must be in good taste; the Airband committee maintains the right to reject any costume or prop. Any costumes that may be considered inappropriate need to be cleared with either the Airband Advisor or the Airband Chairs. Failure to do so may result in point deductions.
5. Chapters may only practice Sunday – Thursday. **Each practice may not exceed two hours and must be completed before 10:00 pm.**
6. Song Selections will be made at the 2/23/2026 meeting.
  - a. **NOTE: Song changes will not be accepted after the Airband meeting on 3/23/2026.**
  - b. **Song selections must be from 2000 to 2010. No remixes will be accepted.**
  - c. **Songs MUST BE the clean version of the song.**
7. All music must be submitted via USB in excellent condition. The USB must be turned into the Airband chairs no later than **March 23, 2026**.
  - a. **NOTE: The USB must include the pairing name and song choices.**
8. The Airband rehearsals will be held on **Friday, April 10, 2026**
  - a. **ALL PARTICIPATING CHAPTERS/PAIRINGS ARE REQUIRED TO ATTEND THE STAGE REHEARSAL on April 10. FAILURE TO ATTEND WILL RESULT IN DISQUALIFICATION.**
9. Throughout each performance, judges will be taking obscene or distasteful dances into consideration. At their discretion, they may deduct points for distasteful actions.
10. Costumes and props will be checked one week prior to the Airband performance.

11. Each Airband participant will have a \$75.00 limit for their costume. A chapter can't spend more than \$300.00 on all props.
  - a. Note: Costume and prop receipts are due **March 23, 2026.**
12. It is mandatory that there are always four people on the stage during the performance.
13. The lineup for Dress Rehearsal and the day of Airband will be selected on **March 23, 2026.**
14. Chapters will receive 15 bonus points for **appropriate** crowd work!

## Deductions

**A deduction may be applied to the overall final performance score or to attendance points, depending on the violation.**

**Performance Deductions** – Five (5) points will be taken away if any of the following happen:

- If there is a prop, costume, move, etc., added to the performance that wasn't shown during the final dress rehearsal.
- If at least 4 people aren't always on stage.
- If you exceed the time limit or don't meet the time minimum.
- If you don't incorporate both chapter(s) in some way, shape, or form (i.e., prop, "throw what you know," verbal/chant, or flag)
- If there is no collaboration of chapters throughout the performance.
- The Airband Committee **DOES** have the final say to deduct points if there is any violation.
- Chapters/Pairings may not reserve or use the Grand Ballroom for Airband rehearsals, try-outs, etc., until their slotted times during the Airband rehearsals week (April 10 and April 11). Chapters/Pairings that are found in violation will be subjected to either point deductions or disqualification.

**Meetings Deductions** – Five (5) points will be taken from your attendance points if you do any of the following:

- Do not show up at meetings; a representative from each chapter must be in attendance.
- If paperwork or materials are turned in late.

## Step and Stroll Competition Information

### Rules and Regulations

1. Only undergraduate members can participate.
2. Time Limit: The Step and Stroll routine may not be less than five (5) minutes long and no longer than seven (7) minutes long.
3. No dances, props, or costumes may include any references to alcohol, controlled substances, racial insensitivity, etc.
4. Costumes can only be removed in an appropriate fashion. Instruments and props are permitted but may not be thrown at any time (Absolutely no throwing objects into the crowd). Your chapter(s) must be incorporated in some way, shape, or form (i.e., prop, throw what you know, verbal/ appropriate chant)
5. Chapters may only practice Sunday – Thursday. **Each practice may not exceed two hours and must be completed before 10:00 pm.**
6. Song changes will not be accepted after the Greek week meeting on 3/23/2026.
7. All music must be submitted via USB in excellent condition. The USB must be turned into Step and Stroll chairs no later than March 30, 2026.
  - a. NOTE: The USB must include pairing name and song choices.
8. The Step and Stroll rehearsals will be held on Friday, April 10, 2026.
  - a. ALL PARTICIPATING CHAPTERS/PAIRINGS ARE REQUIRED TO ATTEND THE STAGEREHEARSAL on April 10. FAILURE TO ATTEND WILL RESULT IN DISQUALIFICATION.
9. Throughout each performance, judges will be taking obscene or distasteful dances into consideration. At their discretion, they may deduct points for distasteful actions.
10. Costumes and props will be checked one week prior to the Step and Stroll performance.
11. It is mandatory that there are at least three to four people on the stage during the performance.
12. All members of the Step and Stroll team must have their Panther Card on the day of Step and Stroll for attendance.
  - a. NOTE: If a Panther Card is not present, members will be unable to participate.

# Tugs

## Rules and Regulations

**ALL ROSTERS, LIABILITY FORMS, SPORTSMAN LIKE CONDUCT FORMS, AND CHAPTER CONDUCT CODES ARE DUE NO LATER THAN MARCH 23, 2026.**

1. All forms listed above must be submitted to the Office of Fraternity and Sorority Life or handed in at a steering committee meeting. No exceptions or excuses will be accepted after the due date. If you miss this deadline, your chapters **WILL NOT** participate in the event(s).
2. Committee Chairs will not be held responsible for names that cannot be read. If your roster is ineligible, we will count it as incomplete.
3. During Tugs, there will be an area separating the tugs lane from the spectators. If any member of your chapter is in that lane at any time during Tugs, the team will be considered in violation of the conduct code and will be disqualified.
4. If a team withdraws from the competition, it will forfeit its seed position. Their team will not place or earn participation points in said event.
5. The event will be held over the campus pond, and the rope will be entirely wet before each Tug begins.
6. The start and end of a tug will be indicated by a **train horn or other amplified sound if the train horn doesn't work.**
7. Only turf or plastic shoes are allowed. No metal cleats may be worn, and judges will check participants' shoes prior to each tug (on the rope).
8. Substitutions of tuggers may be made before the tug but **must be from the alternate listed on the final roster.**
9. The team that can get two tuggers (second tugger knee deep) on the opposing team in the water first will be declared the winner.
10. No team member may assume a position behind the anchorman at any time. Only tugging members may touch the rope after the tug has begun to hold the slack. If necessary, a steering committee member will hold the slack.
11. The team coach may not touch the members once the tug has begun.
12. No more than two team coaches will be allowed in the lane; failure to adhere to this rule will result in immediate disqualification. Warnings will not be given.
13. Coaches must be current EIU students and active members of an Eastern Fraternity/Sorority organization.
14. A flagger is required for each team to raise and lower the flag. The flagger must be a member of the chapter, tugging can be an alternate, and not the Coach. This person must remain silent and clear-headed during the competition and must not move from the flag position.

15. Only the contestants' feet may touch the ground; unless the participant(s) slip or fall, in that event, a judge will issue a verbal warning, and the contestant will have 5 Mississippi's by the judge's count to resume their position. If five Mississippi's are exceeded, and the tugger has not resumed their position on the rope, then the individual will be disqualified.
16. NO SITTING ON FEET WILL BE ALLOWED. If caught sitting for more than 5 Mississippi's count by a judge, the individual will be disqualified.
17. Teams must remain in the tug lanes; otherwise, they will be disqualified. One false start will be allowed per team, per tug
18. Any attachment to a stable object (i.e., fence pole, tree, boulder, light pole with concrete block, a vehicle, etc.) will result in immediate disqualification, without warning, during Round 1, Round 2, Semi-Finals, and Championship tugs. **This includes Tugs practices.**
19. Other immediate disqualifications will result if:
  - a. Intentional forward motion during the explosive stage.
  - b. Intentional release of the rope.
  - c. Intentional interference with the judges occurs (by any member of the chapter)
20. The rope will be entirely placed in the pond immediately after the prior tug. The team will be given a two-minute time limit to dry the rope. Following that, the team will have one minute to approach the rope. The team will then have up to two minutes to get set. When the horn sounds, the tug will begin, and then the horn sounds for the second time when the tug has ended.
21. There will be a two-minute time limit from "Tuggers get set" to "Your team's flag is down." If that time limit is broken, it will be considered a false start.
22. If a team refuses/declines to tug at any point, they forfeit their position and will not receive participation points for the event.
23. If three or more of the tuggers have been removed from the rope by judges or have voluntarily removed themselves from the rope, the tug will be called due to the safety of the tuggers, and the opposing team will have won that tug.
24. Only the Anchors' feet may touch the ground and must always have a hand on the rope; unless the Anchor slips or falls, in that event, a judge will issue a verbal warning, and the contestant will have 5 Mississippi's by the judge's count to resume their position. If five Mississippi's are exceeded, and the Anchor has not resumed their position on the rope, then refer to rule #25.
25. **If the Anchor has been removed from the rope by the judges or has voluntarily removed or untied themselves from the rope, the tug will be called due to the safety of the tuggers, and the opposing team will have won that tug.**
26. No tugging on the following areas: Rugby Field, Football field, Church behind old Sigma Phi Epsilon house, the pond, IM fields, and band practice field. The Greek Week Steering Committee has the right to add more areas to this list at any time.
27. Every member must sign a liability form and return it to the Rules and Games Committee by **March 23, 2026**; otherwise, the entire team will not be able to tug. **NO EXCEPTIONS.**

28. Every member must also sign the sportsmanlike conduct agreement before they are allowed to tug. This is also due by **March 23, 2026**.
29. Chapters may only practice Sunday – Thursday. **Each practice may not exceed two hours and must be completed before 10:00 pm.**
30. **NO TRAINING, CONDITIONING, OR PRACTICES AS A TEAM UNTIL FEBRUARY 9, 2025**
31. Failure to abide by the above practice regulations may result in the following:
  - a. Verbal warning by the Greek Week Steering Committee
  - b. The Greek Week pairing will lose sportsmanship points
  - c. Tug Team will be disqualified from participating in Tugs.

### Rules and Regulations

#### **Banner**

1. Banner must incorporate the Greek Week Theme.
2. Banner must include the pairings chapter's letters and symbols.
3. Banner cannot degrade EIU, another chapter, chapters, or a staff member of the University.
4. Please be creative, but appropriate and tasteful.
5. Banners need to be turned in to Nathan's office **by 4:30 pm on APRIL 1!**
  - a. **BANNERS MUST BE FULLY DRIED!!**
  - b. If not turned in on this date, chapters will receive a 5-point deduction.
6. Banner will be hung between the following dates:
  - a. Friday, April 3 – Saturday, April 12, 2026.
7. Banners **MUST BE** the following size:
  - a. 3.5ft wide and 6ft tall or 42in x 72in.
8. Pairings for a window number will be drawn at the 3/30/26 Greek Week delegate meeting.
9. NPHC chapters and NALFO chapters can create a community chapter Greek Week banner. They will have their own window.

2. The location will take place in Groniger Arena
3. Time of event will be 7:00 pm – 9:00 pm
4. Chapters will earn points for attending as follows:
  - a. 1% - 49.9% of the chapter in attendance will earn 25 points
  - b. 50% - 100% of the chapter in attendance will earn 50 points.
5. Each chapter will be awarded points within its pairing; triple pairings will be awarded points as if they were a double pairing.
6. Points will be awarded for the men's game, and chapters will receive 5 bonus points if they provide an individual for games throughout the basketball game via the MachForm.

#### **Greek Week - Game Night**

7. Will take place on Tuesday, April 7, 2026
8. Location will take place in Buzzard Auditorium
9. Time of event will be 7:00 pm – 8:30 pm
10. Chapters will earn points for attending as follows:
  - a. 1% - 49.9% of the chapter in attendance will earn 25 points
  - b. 50% - 100% of the chapter in attendance will earn 50 points.
11. Each chapter will be awarded points within its pairing; triple pairings will be awarded points as if they were a double pairing.
12. Must have at least four to six participants for Game Night.

3. Time of event will be 12:00 pm – 4:00 pm
4. Chapters will earn points for attending as follows:
  - a. 1% - 49.9% of the chapter in attendance will earn 25 points
  - b. 50% - 100% of the chapter in attendance will earn 50 points.
5. Each chapter will be awarded points within its pairing; triple pairings will be awarded points as if they were a double pairing.

**Fraternity and Sorority Experience Survey:**

**Order of Omega Case Study Competition**

1. The **PURPOSE** of the Case Study Competition is to provide an educational learning experience for those undergraduate members of fraternities or sororities as well as fraternity/sorority professionals.
2. The Case Study Competition offers participants and judges a practical educational opportunity to learn from one another. Participants and judges establish professional relationships and networks that foster future professional development opportunities.
3. Confidentiality regarding the cases used for the Case Study Competition must always be maintained. Participants may only discuss the case study with their partner. They may not share the case study with anyone else. Participants may use any other resources that are available to them, except for another person, as noted above.

- a. Failure to keep the case study confidential will result in either a point deduction or removal from participating.
4. Participants
  - a. Judges are there to provide positive constructive feedback.
  - b. Remember, this is a practical educational learning experience.
  - c. Try to put yourself in the role of the judges.
  - d. Have a positive attitude.
  - e. Be realistic throughout your presentation.
5. Judges
  - a. There are three judges for the case study.
  - b. Judges will present a final ranking of all participating teams.
  - c. Judges will NOT make decisions on participant disqualification. Decisions of this nature rest solely with the Office of Fraternity & Sorority Life.
6. E. General Outline for Presentations
  - a. Participants are directed to their seats.
  - b. Participants introduce themselves to judges.
  - c. Judges introduce themselves to participants.
  - d. The spokesperson (Judge) asks participants to "Please begin."
  - e. Participants present the case for 15 minutes.
  - f. Participants inform judges, "This completes our presentation".
  - g. Judges ask participants questions and provide oral feedback. (5min)
  - h. Participants are excused.
7. Rules & Regulations for Presentations
  - a. Due to electronic device rental fees and a disadvantage to those without access to such devices, the use of technology in the presentation is prohibited.
  - b. Participants may have notes to present from.
  - c. Books, websites, and other relevant material may be used as resources for the presentation.
  - d. Participants may not ask anyone other than their partner for assistance or advice in handling the case.
8. Pairings will select/provide two to three individuals from their pairing to participate. One individual must be from a fraternity, and one or two individuals must be from a sorority.
9. Pairings will receive 20 points for participation.
10. Pairings will be receiving the following points and monetary compensation
  - a. First Place – 30 points, plus \$250.00 dollars split among participants.
  - b. Second Place – 20 points, plus \$150.00 dollars split among participants.
  - c. Third Place – 10 points, plus \$100.00 dollars split among participants.
11. Participants will receive the Case Study on Monday, April 6, 2026, at 9:00 pm.
12. Order of Omega Case Study judging will be taking place on Thursday, April 9, 2026.
