



**Sarah Bush Lincoln – Eastern Illinois University Medical Clinic
Patient Eligibility and Cost of Services for Medical Clinic**

Registered Students – On-Campus

Eastern Illinois University students registered for one credit hour or more of courses deemed to be within on-campus programs and who pay the Health Services fee are eligible for all services provided through the Sarah Bush Lincoln (SBL) – Eastern Illinois University (EIU) Medical Clinic at the student rate for billing.

The Health Service fee is different from the Student Insurance fee which provides coverage for medical services delivered off-campus. Information regarding the student insurance plan may be found at: <https://www.eiu.edu/studentinsurance/>

Services through the SBL-EIU Medical Clinic are available for registered students starting on Monday, the week before classes start, and prior to the beginning of each semester. Services are available to registered students, at the student rate for billing, who are participating in official university business upon their return to campus, no earlier than August 1 for fall, Jan. 1 for spring and the Monday after spring graduation for summer. At the conclusion of each semester, continuing students may continue to use the Medical Clinic at the student rate for billing until the week before classes start for the following semester.

Registered Students – On-line/Off-Campus/ Continuing Education

Students enrolled in five or more on-line/off-campus classes have the option to pay the Health Services fee to utilize the medical clinic.

Non-Registered Continuing Students during Summer Terms

Individuals who were previously eligible to utilize the Medical Clinic during the Spring semester, may use the Medical Clinic during the Summer if they are registered for the upcoming Fall semester by paying the entire summer term's Health Service's student fee. This includes students who are working on or off campus, living in the community, etc.

Students participating in required official University activities, such as Athletics, New Student Programs and Camps & Conference, who are unable to register for summer classes because of their official activities may be waived from paying the summer term's Health Service's fee. during

the summer may use the Medical Clinic at the student rate for billing if they are registered for the upcoming fall semester. These students must be identified by the affiliated department, entered an on-line system, and approved by the Executive Director of Health and Counseling Service. Students utilizing the medical clinic will be responsible for standard and customary charges which will be applied to their student account.

Graduates

Students who graduate may no longer use the Medical Clinic, effective the Monday after graduation.

Students Who Withdraw from the University during the Semester

Students who withdraw and are no longer attending Eastern may not use the Medical Clinic, effective after the last day of enrollment.

Campus Visitors/ Camps and Conferences

Visitors to campus, including those participating in university affiliated programs or services, are not eligible to use the Medical Clinic.

Faculty/Staff

Faculty and Staff are not eligible to use the Medical Clinic at the University. These should utilize their normal medical providers and urgent care. In emergency situations, 911 should be called for local emergency medical services.
