OPEN ENROLLMENT: FY26 IACSUB SURVEY

OVERVIEW

This survey is to determine the current incidence and prevalence of alcohol and other drug use on Illinois 2 and 4-year college campuses. Furthermore, students' perception of others' use; perceptions of risk related to use; beliefs regarding use; negative consequences associated with use; experiences of secondhand effects of others' use; experiences of physical and sexual violence; and the relationship of alcohol and other drug use to campus climate issues will, also, be examined.

Benefits:

- No cost to your institution
- Survey results are done in house, meaning quicker distribution
- Survey results will not be shared with other institutions, only you or delegated persons will receive a copy of your institution's results
- Administration will be done in early spring pending approval, will run for approximately 3 weeks.
- Conducting needs assessment will help target prevention resources and make programming efforts justifiable, fundable and measurable.
- Data can also assist in defining the nature and extent of the campus alcohol and other drug problem and in identifying high-risk groups within the campus

REQUIREMENTS FOR PARTICIPATION:

Send us a letter on the facility's letterhead stationery or e-mail, and should contain the following:

1. Agreement for the study to be conducted at the site
2. Identification of someone at the site who will provide information about appropriateness of the study for its population
3. Assurance of adequate capabilities to perform the research
4. As approved by the IRB; and if applicable
5. Assurance that facility personnel involved in data collection have appropriate expertise and will follow IRB approved procedures.

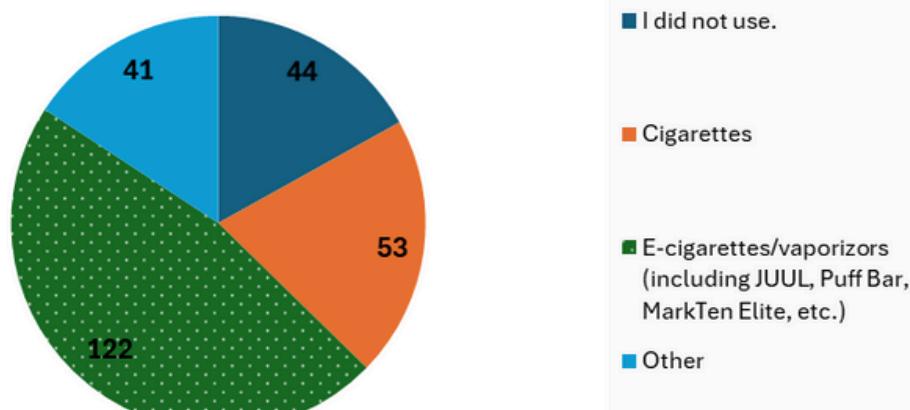


FY24 IACSUB TOBACCO AND NICOTINE DATA BRIEF SNEAK PEEK

WHICH OF THE FOLLOWING TOBACCO/NICOTINE PRODUCTS DID STUDENTS USE IN THE PAST 12 MONTHS?

Participants could check that they used any combination of cigarettes, E-cigarettes/vaporizers, and other if each applied to them. The feedback for this question totaled 260 responses. The collected findings for how students consumed tobacco/nicotine were 46.9% (n=122) E-cigarette/vaporizer use, 20.4% cigarette use (n=53), and 15.8% use of other products (n=41). The remaining 16.9% of participants (n=44) answered that they had not used any tobacco/nicotine products.

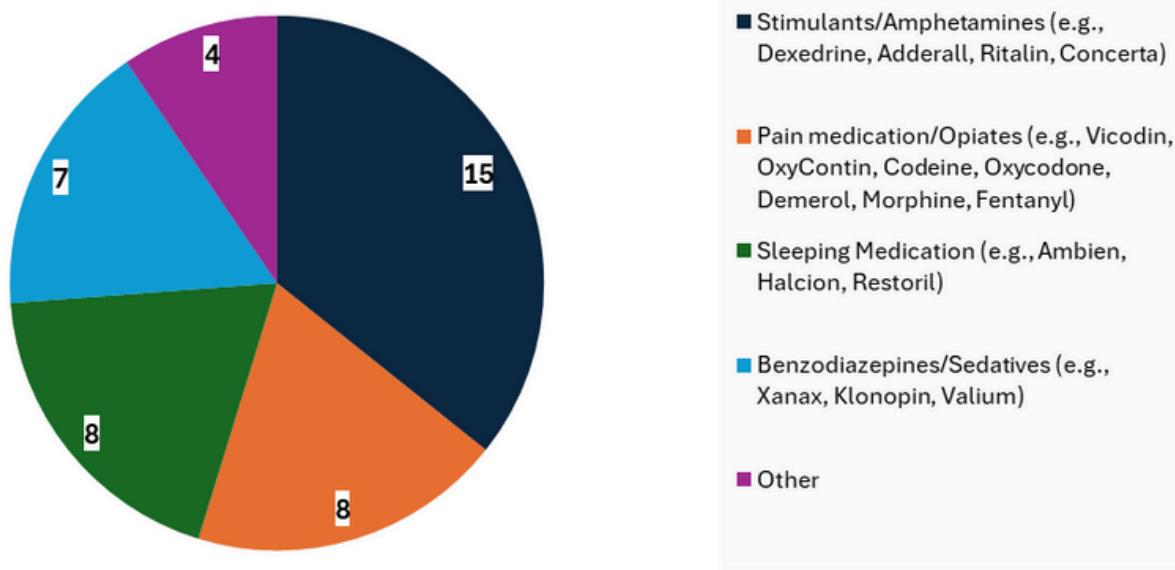


FY24 IACSUB PRESCRIPTION DRUG DATA BRIEF SNEAK PEEK

WHICH OF THE FOLLOWING TOBACCO/NICOTINE PRODUCTS DID STUDENTS USE IN THE PAST 12 MONTHS?

Out of the 705 total participants in this survey, there were 640 that answered this question. Of these respondents 93.4% said they have not used prescription drugs without a prescription in the past year(n=598). There were 15 people who preferred not to respond. Figure 4.1 looks at the remaining 42 students who took prescription drugs and which they chose to use.

NEW SELF-ASSESSMENT TOOL

Our staff is looking forward to implementing this new self-assessment tool for prevention. In this toolkit, professionals will be able to take the assessment, receive feedback based on their score and find relevant resources for each category. Under the "Prevention Assessment" tab on our website, visitors will be able to browse a robust variety of recorded webinars, worksheets, printed publications and more.

After receiving feedback from the rubric, there is an opportunity to book a consultation with one of our staff members to discuss ways to improve campus prevention efforts. For many, this resource will be a stepping stone for the Biennial Review and the Illinois Assessment of College Substance Use Behaviors. Our goal is to be able to utilize this assessment as a pre-post test for many of our affiliates, providing assistance as needed to help improve their prevention efforts.
