#### **COMMUNICATION:**

\_\_\_\_\_ I understand that all communication, including correspondence regarding tuition, course information, enrollment, drop deadlines, as well as payment information and receipts, will be conducted through my Eastern Illinois University (EIU) email account.

\_\_\_\_\_ I will check my EIU email account regularly for correspondence from the university, School of Extended Learning, and from the Department of Music.

\_\_\_\_\_ If I need technical assistance with my email account, I will contact PantherTech at 217-581-4357 (217-581-HELP).

#### **TUITION WAIVERS:**

\_\_\_\_\_ Because this program is administered by the School of Extended Learning, I understand that Tuition and Fee Waivers and scholarships cannot be used because this program is sponsored by agencies that are not under obligation to fulfill financial renunciations issued by Eastern Illinois University or its affiliates. **Military** must notify the School of Extended Learning to use Military waivers or benefits.

#### **PAYMENT:**

\_\_\_\_\_ I understand that payment will be made through the EIU student account system and that I may receive notification of bills through my EIU email account, not my personal email account.

\_\_\_\_\_ I understand that I need to check my EIU email account for tuition/fee payment information.

\_\_\_\_\_ I understand that any financial aid received will be reflected on my student account. If financial aid is not reflected, I will contact the financial aid office at 217-581-6405.

### ENROLLMENT/DROPPING A CLASS:

\_\_\_\_\_ I understand that once accepted into the program, I will be automatically enrolled directly into the recommended class(es) each semester.

\_\_\_\_\_ I understand that I must communicate with the Department of Music prior to the drop deadline for the semester if I DO NOT wish to participate in classes in a given semester.

### COURSE PARTICIPATION:

Any exceptions must be approved by the instructor in advance unless it is an emergency that meets the guidelines of Eastern Illinois University. Documentation may be required.

\_\_\_\_\_ I understand that online classes may have synchronous requirement that will be made clear at the beginning of the semester and that I am expected to participate in synchronous components.

### SUMMER RESIDENCY:
