## **TERMS OF AGREEMENT**

The transition to a post-secondary university education environment involves many new experiences and some challenges. By signing this agreement, we (student and parent/guardian) understand that the purpose of STEP is to guide the student in gaining a greater understanding of themselves while assisting them in their efforts to assume responsibility and control over areas of their lives as young, adult college students. We understand that STEP provides services intended to support participating students in aspects of organization, planning, prioritization, time management, self-monitoring, self-regulation, insightful and flexible communication, social involvement, and self-advocacy. We further indicate our understanding that STEP is not a special education program and is not designed nor intended to teach, re-teach, or modify the academic curriculum requirements of the University or the courses your college student enrolls in. We are here to help college students who desire to participate in our program, and who are academically transition-ready for the college classroom, to become responsible for the success of their college career and goals. As a parent/guardian I understand that I will support my student's STEP team in guiding my student to become a self-efficacious young adult.

We further understand that to remain eligible for participation in STEP at EIU, the student must attend and actively participate in all STEP services; adhere to University attendance requirements; meet University Satisfactory Academic Progress and GPA requirements; adhere to EIU Student Conduct Code <a href="https://www.eiu.edu/judicial/studentconductcode.php">https://www.eiu.edu/judicial/studentconductcode.php</a>; demonstrate responsive and positive communication with STEP staff; engage in respectful interactions with other students in STEP, and refrain from disrupting or interrupting STEP services. *Students may be dismissed from STEP should they fail to adhere to these requirements.*
